	Serve as a Project Coordinator for specified projects and/or programs: Plan and develop population and evidence-based interventions to promote wellness for community members of Clark County. Collaborate with community members through person-centered program planning to overcome implementation barriers. Design the composition of program and public health promotion. Coordinate and evaluate the program, including developing promotional materials and messages. Create or facilitate training curriculums for stakeholders and community partners, as well as training of consumers on program details. Write and assess all reporting and data analysis requirements. Conduct financial and programmatic tracking and reporting, communicate with all funding sources, complete all necessary documentation, and oversee/monitor all related projects/activities. Serve as a resource to the community and other organizations/agencies. Participate in or convene community committees, work events and special projects, and develop materials/presentations. Answer general public health-related inquiries and maintain regular contact with partners.
