Clark County Combined Health District Board of Health Minutes August 18, 2022

President Dala DeWitt called the August 18, 2022, Clark County Combined Health District Board of Health meeting to order at 6:00 p.m.

Board members present: Catherine Crompton, Dala DeWitt, Bernadette deGuzman, Scott Griffith and Valerie Moore.

Board members absent: Tyler Walters and Dana King.

Staff present: Charles Patterson, Health Commissioner; Larry Shaffer, Environmental Health Director; Christina Conover, Director of Nursing; Lori Lambert, Early Childhood Director; Emily Thomas, WIC Director; Lindsey Hardacre, Fiscal Officer 2, Chris Cook, Assistant Health Commissioner; Stephanie Johnson, Emergency Preparedness Coordinator and Nate Smith, Communications Coordinator.

Guests: none.

Minutes: The minutes of the Board of Health meeting held on July 27, 2022, were approved as submitted.

Activity Reports

<u>Nursing</u>: Ms. Conover said that we continue to provide COVID vaccines and are anticipating being able to administer the bivalent vaccine which will be an additional booster. She said that the bivalent is not yet available, however, we are starting to get calls and questions from the community, so we have requested two (2) nurses from Prolink to help with our vaccine clinics. She said the two (2) nurses started this week, which will be a tremendous help with the COVID and back to school vaccines.

Ms. Conover said that we do not currently have any identified cases of Monkeypox in Clark County, however, some of our surrounding counites do so we anticipate that one of our providers will identify a positive case. She said that we did order vaccine, however, right now the state is in a transition period of the vaccine only being available for people identified as direct contacts of positive cases transitioning to a high-risk population. She said that we are still trying to figure out how that tiering system will go with differing case counts throughout the state. She said that initially the vaccine is delivered subcutaneously, however, they did approve an emergency use authorization which will allow some people aged 18 and over a dose intradermally. She said the benefit there is that one (1) dose becomes four (40) to five (5) doses. She said that as of this evening there are 123 cases in Ohio. She said that Mr. Patterson will speak more to this later in the agenda.

Ms. Conover said that our back-to-school vaccinations are in full swing. She said that we met with some Springfield City school nurses last week and we look forward to working with them.

She said sexual health and wellness had two (2) successful opportunities to go to provider offices to talk about syphilis and secure collaboration with them and thanked Ms. Britney Bruce for work with that.

Ms. Conover said that we have had many personnel changes over the past couple of years, so we do not always mention the comings and goings in an effort not to miss someone but wanted to mention the addition of a couple co-workers as their capacity is a little different. She said through the Educational

Service Center (ESC) we are able to have two (2) co-workers, one who is bilingual in French Creole and one bilingual in Spanish. She said that it has been nice to have both with us to help develop relationships.

<u>Environmental Health</u>: Mr. Shaffer said that we had an agenda item for a variance removed tonight and thanked the board again for passing the variance policy, which we have been able to use on a couple instances and it made the process easier for all involved.

Mr. Shaffer said that today is the last day for our mosquito intern so we will discontinue collection of samples for the rest of the season. He said that we have met our requirements and have collected twenty (20) positive samples for West Nile Virus so far. He said that we are number three (3) in the state for collecting positive samples and number nine (9) in the state for collecting total number of mosquitos at over 13,000 so far. He said that we do expect to change how we apply control products next year and plan to reach out to more areas. He said that it has been a struggle to keep up this year due to staffing shortages which is the reason the mosquito collection is being discontinued.

<u>Early Childhood:</u> Ms. Lambert said that we have been interviewing for one full-time and two (2) part-time open positions and are currently in the offering stage and hope to be back next month with three (3) new team members.

Mr. Lambert said that we have been diligently gathering documentation to show our evidence-based model Healthy Families America that we are following their model and that documentation is due to them by September 6, 2022. She said that they will fly-in October 16, 2022 through October 18, 2022 to do an onsite visit and we look forward to having them here.

Mr. Lambert said that Governor DeWine's office has asked us to take one of their key advisors on a home visit in Clark County to show them the value of Help Me Grow so we will do that on September 13, 2022 and look forward to that as well.

<u>WIC</u>: Ms. Thomas said that our caseload has dropped just below 3,000, however, still is above our state assigned level. She said that we are one of the six (6) counties out of seventy-four (74) above the state assigned level, so we are pleased with that.

Ms. Thomas said that the formula shortage is still a concern and substitutes are temporarily available under most of our packages. She said that the state office is continuing to watch the situation and provides weekly updates.

Ms. Thomas said that August is breastfeeding awareness month or as we like to call it BAM. She said that Ohio has adopted the theme, "step up for breastfeeding, educate and support" which focuses on the role we all have in the survival and well-being of all and the work to protect breastfeeding worldwide. She said in celebration of BAM our program is having an event next Friday afternoon at the WIC/EC building. She said that we are providing flyers and invitations to our participants to join us to learn more about breastfeeding and receive support items.

Ms. Thomas said that we are happy to report that our application for the WIC grant has been processed and we received notice of award for that grant starting fiscal year 2023.

<u>Health Planning</u>: Mr. Cook complimented our team and first responders in the community on the overdose map project. He said that this is an advancement of something we started with Springfield Fire & Rescue that will provide us with more real time data of when we have spikes and increases in overdoses in the community that can be indicative of laced drugs causing overdoses more than we would expect for

this time of year. He said that this project will allow our quick response team to have that real time data and get out into the community to make people aware of these potential drugs on the street that are causing people to overdose.

Mr. Cook said that our annual report for the public health accreditation board was submitted on July 27, 2022, and that it is currently under review which typically takes a couple of months to approve. He said that this is something that we will complete once per year during our five (5) year process, and we are looking forward to that feedback.

Mr. Cook said that we are happy to share that we received our award for the substance abuse program in the amount of \$175,000.00. He said that we have a kickoff event coming up on August 26, 2022 for our drive sober or get pulled over campaign that will be held at Youngs Jersey Dairy from 11:00am to 2:00pm. He complimented our lead team, Caroline, Leslie, and Gracie for their work making strides in educating providers, realtors and other partners in the community doing lunch and learns to understand what lead hazards are and how they can access help. He said this work could not be done without the great partnerships in our community.

<u>Vital Statistics</u>: Mr. Patterson said that the vital statistics birth data is incomplete for July as we are experiencing some issues with data from the hospital so we will update that report next month.

<u>Financial Report</u>: Ms. Hardacre presented the financial report said that we have submitted five (5) grants in the past one and half months with the Ohio Department of Health behind in grant submissions, but we continue to submit those with the next coming in October.

<u>Legislative Update</u>: Mr. Patterson said that the legislature has not been in session so there has not been much activity. He said Dr. Vanderhoff, the Director of Health will be visiting our health district on September 12, 2022 and invited the board members to attend.

Water Pollution Control Loan Fund Request to OEPA: Mr. Shaffer said that since 2018 we have been entering into an agreement with the OEPA to receive funding designed to reduce the pollution to the water from household sewage treatment systems. He said that to date we have been awarded \$950,000.00 and have spent \$666,000.00. He said that the money goes directly to repairs and replacements for household sewage treatment systems for individual property owners. He said that it is a fantastic program that brings money into Clark County to our individual property owners. He said that we have completed 47 projects with the average benefit being approximately \$14,000.00. He complimented the staff as the program is a lot of work. He said that we are down to two (2) septic installers which is why we have not spent the entire \$950,000.00. He said that we are asking for permission to continue with that program this evening.

R 82-22 A resolution authorizing the Health Commissioner to apply for, accept, and enter into a Water Pollution Control Loan Fund Agreement on behalf of the Board of Health of the Clark Country Combined Health District for the repair and replacement of household sewage treatment systems.

Whereas the Clark County Combined Health District seeks to repair and/or replace failing home sewage treatment systems; and

Whereas the Clark County Combined Health District intends to apply to the Water Pollution Control Loan Fund (WPCLF) for the repair and/or replacement of failing home sewage treatment systems; and

Whereas the Ohio Water Pollution Control Loan Fund requires the government authority to pass legislation for application of a loan and the execution of a WPCLF assistance agreement; now therefore,

BE IT RESOLVED by the Board of Health of the Clark County Combined Health District of Springfield, Ohio:

SECTION 1. That the Health Commissioner be and is hereby authorized to apply for a WPCLF assistance agreement for the year 2023, sign all documents for and enter into a Water Pollution Control Loan Fund with the Ohio Environmental Protection Agency for the repair and/or replacement of failing home sewage treatment systems on behalf of the Board of Health of the Clark County Combined Health District of Springfield, Ohio

SECTION 2. That is resolution shall take effect and be in force from and after the earliest period allowed by law.

<u>Disease Investigator Position</u>: Ms. Conover said that it is a challenging time to attract staff which includes nursing staff that is starting to affect programs so we decided to make some changes to the communicable disease nurse posting to a disease investigator posting that will be supported by the nursing team. She said that we feel this is necessary and manageable.

<u>Springfield Foundation Grant Submissions</u>: Ms. Conover said that we have an opportunity to apply for grants with one being a request for funding for two (2) additional Binx machines that give us chlamydia and gonorrhea results. She said that we have two (2) machines which has been successful, however, we have tried to transport the machines between our Southern Village location and Home Road which causes extra wear and tear on the machines.

Mr. Cook said that we submitted two (2) other applications, both of which complement other funding we have already received from the Community Health Foundation. He said we previously received \$25,000.00 from the Community Health Foundation for an Infant Vitality Coordinator and asked for \$50,000.00 from the Springfield Health Foundation to make that a full-time position. He said that this ask is to align with one of our community health improvement priorities to decrease our adverse birth outcomes, decrease preterm births, increase healthy birth outcomes, and decrease mortality. He said the second application

is to compliment the Community Health Foundation's funding of \$45,000.00 for what we called a minority health connection. He said that we asked for another \$50,000.00 from the Springfield Health Foundation to establish, equip and renovate a new or alternative location somewhere in the south corridor to provide these services in the neighborhoods where we need them. He said when we looked at the possibilities there was some overlap between the data first project where we targeted certain census tracks for the COVID vaccine with a similar approach to bring public health services to the same corridor.



- COVID-19 vaccinations continue to be provided at 529 East Home Road on Mondays, Thursdays and Fridays with the help of our staff, our PRN staff and our two Prolink/ODH staff. Many thanks to the staff who have also returned to help schedule COVID vaccines.
- During September 2022, bivalent booster vaccines made by Moderna and Pfizer were released. Since September 8th, just over 700 vaccines (mostly bivalent boosters) have been given.

Monkeypox (MPXV) Response:

- On September 19th, CCCHD did a press release to note that there is one case of probable monkeypox diagnosed in Clark.

• United States: 23,893

Ohio: 248

Clark County: 1


- Limited amount of vaccine has been issued to CCCHD and doses are pre-arranged and offered to eligible persons once a week in an effort to waste as little vaccine as possible.
- Persons indicate their interest and attest to their eligibility through a link on CCCHD's website.

The Clark County Combined Health District is using the Centers for Disease Control and Prevention's tiered approach to vaccine distribution as guidance during this time of limited vaccine availability. Currently to receive a vaccine individuals must meet one of the following criteria:


- You are at high risk of being exposed where you work (lab workers testing monkeypox samples).
- You are a close contact of someone who has been diagnosed with or tested positive for monkeypox.
- You attended an event or activity where there were monkeypox cases or known transmission.
- You are a man, transgender woman, or non-binary person who has or plans to have sexual encounters with men AND you or your partner have risk factors such as:
 - HIV positive or living with AIDS
 - diagnosed with and STI/STD in the last 12 months
 - history of multiple or anonymous sex partners
 - participate in group sex
 - attend sex-on-premise venues or events
- You or your partner exchange sex for money, goods or services.

Routine Immunizations and Get Vaccinated Ohio (GVOH)









Healthy Families America[®] (HFA) is the nationally recognized, evidence-based home visiting program of Prevent Child Abuse America®. The HFA network includes close to 600 sites that annually serve almost 70,000 families with more than 950,000 home visits across 38 states, DC, all 5 territories, and Israel.



- HFA's most rigorous evidence includes 35+ peer-reviewed published articles and 14 randomized control trials that compare outcomes for families enrolled in HFA to those not offered HFA services.
- Research over the past 30 years has shown positive results and sustained impact with HFA families in geographically and racially diverse communities experiencing various amounts of stress and challenge.
- HFA has positive findings in all eight domains examined by the HHS Home Visiting Evidence of Effectiveness (HomVEE) review and 40% of HFA sites receive funding from the Maternal Infant Early Childhood Home Visiting (MIECHV) program.
- HFA is rated at the highest level (well-supported) by the Title IV-E Prevention Services Clearinghouse for the Family First Prevention Services Act (FFPSA).

HFA reduces barriers and connects families with essential community services, including referrals to health services and links to economic supports such as TANF and SNAP benefits.

In HFA families, there is less intimate partner violence and fewer incidents resulting in injury.



Understanding Return on Investment

What is HFA's Return on Investment (ROI)?

A recent study estimates HFA's ROI at \$1.46.2 This means that every \$1 dollar spent on HFA produces an estimated \$1.46 in benefits for families and society. In other words, HFA produces more benefits than the cost of providing the services. For some families, ROI is even higher. A 7-year study found an ROI of \$3.16 for families involved with Child Welfare.

How is ROI measured?

ROI is the ratio of service cost to monetizable benefits. The analysis accounts for program cost, outcomes, and research evidence linking those outcomes to later costs and benefits over the lifespan.

For example, HFA children experience early school success, reducing the need for special education and making it more likely that they will graduate, earn a higher income, and contribute more tax dollars as adults. Savings from special education, plus the increased tax revenue when children grow up, help to recoup the money spent on the service.

How much is a healthy parent-child relationship worth?

ROI only looks at outcomes that are tied to a specific cost, such as educational success, foster care, public assistance, or medical care. Many valuable outcomes don't have a monetary value, such as improved parent-child interaction. Others include positive parenting skills, self-efficacy, social support, reduced parenting stress, and more. It's important to remember there are more benefits from HFA than what is measured with ROI. In addition, cost-benefit analysis is an evolving science, and estimates can change as new data emerges.

What's the bottom line?

Research demonstrates HFA's positive return on investment, with substantial benefits for families and society as a whole. HFA shows impacts in all eight domains examined by the Home Visiting Evidence of Effectiveness (HomVEE) review for the MIECHV program.³

One2One Update:

- **Second Harvest Food Bank (SHFB) Partnership**: Over the month of August, we gave out 50 food boxes to our clients.
- Interfaith Hospitality Network (IHN) Partnership: Over the month of August, we completed 3 housing referrals.
- Department of Job and Family Services- Clark County (DJFS-CCO Partnership): Over the month of August, we assisted 4 clients in completing applications for Medicaid and SNAP benefits.

August 31st marked Intentional Overdose Awareness Day. The Clark County Substance Abuse
Coalition in collaboration with Partners in Prevention, Family of Addicts Bridge of Support, and
the Mental Health and Recovery Board hosted a Chalk the Walk memorial event. This was an
opportunity for anyone to come a send a message of hope/remembrance of some who has
passed away due to an overdose. The event ended with a short remembrance walk. The event
was well attended and received positive media coverage. A sampling of artwork from the event


Maternal Child Health Program (MP):

Objective 2: Preconception Health/ Start Strong

- The Start Strong Coalition is currently working on updating their strategic plan. Goals and strategies of the plan include safe sleep, breastfeeding, fatherhood engagement, social determinates of health, substance use during pregnancy, and pre-natal care.
- One of the current goals of Start Strong Clark County (SSCC) is to increase awareness of local resources for expecting mother's and families with babies. One strategy to accomplish this to create a local website that houses resources, contact information, and educational material. Start Strong leadership has worked with a web designer to create and launch the website. The website is now live and a roll out has begun. You can find the website by visiting, https://startstrongcc.org/.
- We received our Notice of Award for the next great year beginning on October 1st. The total award is \$132,000.

Safe Communities:

 On August 26th, we hosted our Drive Sober or Get Pulled Over Campaign Kick-off at Young's Dairy. We had participation from the State Highway Patrol as well as the Clark County Sheriff's Office. Resources on the dangers of impaired driving were provided and there was also an opportunity for individuals to utilize a driving simulator the demonstrates the effects of impaired driving.









Tobacco:

- We are collaborating with Clark County Partners in Prevention in creating an
 implementation plan to conduct youth tobacco prevention activities in Clark County.
 Activities that will be completed include county wide tobacco education, tobacco
 industry awareness, youth cessation promotion, parent education and partnering on the
 activity of conducting compliance checks for tobacco retailers.
- Currently conducting a Tobacco Community Survey. The goal is to reach 300
 respondents by the end of September. A link to the survey is on the CCCHD website, has
 been promoted on social media, and has been included in our outreach at events and
 health fairs.

Creating Healthy Communities:

 Attended the Clark County Local Foods Council (CCLFC) on August 24th, and we have been working on getting the Food Access Committee back up and running to report back to the CCLFC. We are working on a collaboration between food access and the One2One needle exchange.

Lead-Safe Homes:

- Continuing to expand and strengthen partnership with Crabill Foundation, City of Springfield Development Division and Neighborhood Housing Partnership of Greater Springfield as we further develop the Lead Hazard Control and Healthy Homes pilot program. Two properties identified as potential participants (30 Lagonda Ave and 350/352 W State St); initial viability inspection completed for both properties and owners notified of required safety and habitability and/or structural concerns that need to be addressed prior to signing LHCHH participant contractual agreement. 30 Lagonda Ave and distributed by NHP, required contractor walkthrough completed and bids are due Friday, September 2nd. 350/352 W State St project specifications and bid packet in development.
- Prepared targeted letter and finalized attached brochure to send to new Clark County parents. Brochure focused on lead poisoning, what it is, sources and effects of exposure, lead safe steps parents can take, lead testing requirements, and more. Once letter is finalized, plan is to send staggard mass mailings to new Clark County parents from 2020 onward. Clark county births in 2021 total 1047 and between January-July 2022 there were 626 births. 2020 database will be received in September.

- Lead Initiative Lunch and Learns executed 3 additional pediatric/family practice lunch and learn presentations for all healthcare provider's staff to promote general lead education and awareness and to ensure healthcare providers, particularly physicians, are aware of their responsibilities regarding screening and testing children for lead poisoning (see attached PowerPoint presentation for pediatric/family practice physicians). Presentations well received and lead safe literature left with each location for their distribution to their patients. Since June 28th, a total of 7 lead lunch and learns executed.
 - Lunch and learns conducted this month at Family Practice Associates, NOVA pediatrics and Rocking Horse.
