Clark County Combined Health District
Board of Health Minutes
July 20, 2023

President Dala DeWitt called the July 20, 2023, Clark County Combined Health District Board of Health meeting to order at 6:00 p.m.

Board members present: Dala DeWitt, Sherry Robinette, Mike Adamson, Scott Griffith, and Dana King.

Board members absent: Bernadette deGuzman and Valerie Moore.

Staff present: Charles Patterson, Health Commissioner; Larry Shaffer, Environmental Health Director; Christina Conover, Director of Nursing; Lori Lambert, Early Childhood Director; Emily Thomas, WIC Director; Shannon Hackathorne, Administrative Assistant to the Health Commissioner; Lindsey Hardacre, Fiscal Officer; Chris Cook, Assistant Health Commissioner, Dr. Laura Thompson, Medical Director, Carolyn Barnett, PRN Public Health Nurse and Helaina LeCaptain, Epidemiologist.

Minutes: The minutes of the June 15, 2023, Board of Health meeting were approved as submitted.

Activity Reports

Nursing: Ms. Conover said that she would like to give a shout out to the Medical Reserve Corp team, which is a group of public health volunteers that Ms. Sandy Miller coordinates and some other staff help support. She said that this team as well as some of our staff had the opportunity to assist with the additional emergency shelter space and bed frame assembly. She said that they also had some revamping of a project that is the care team which is highlighted in the board packet. She said that this project is intended to be a support for families of persons who committed suicide. She said that the partners in this team are the coroner, law enforcement and agencies which might be at the site of a suicide. She explained that this team would be there to support the family members during that very vulnerable time. She said that this has been a long-term project and the Mental Health and Recovery Board is a valuable partner and big supporter of this project being restructured. She said that some of our board members are also MRC members, so we wanted to bring attention to the new branding and new energy behind this project. She said that our county coroner, Dr. Brown, has also been very involved with this iteration of the project which has been very positive.

Ms. Conover referred to the second quarter communicable disease report included in the board packet. She explained that there is a list of diseases that are defined as reportable in Ohio so when labs, doctors or other healthcare agencies find a positive result that indicates one of those reportable diseases it is entered into a system called the Ohio disease reporting system which is then sorted out by county and that is where these numbers come from. She said that we do not interact with all the people as their provider through our clinics, but we do interact as the reporting and investigation agency with one of our roles being surveillance to see where trends are going. She said that we are optimistic about what appears to be a decrease in chlamydia infection if you compare the numbers between 2022 and 2023 and this is the first time that we have had a downtrend for a while. She said that it may be too early to call but similarly gonorrhea is seeing a decrease. She said that unfortunately our HIV numbers remain high when

compared to last year at this time however when we were able to dig into those numbers, we found that sometimes people have moved here that had a previous diagnosis but were not necessarily reported in the Ohio disease reporting system so that brings our number up. She said that this is not the case with everybody, so we are continuing to watch that. She said when comparing all stages year to date for the first time in a while there is a decreasing trend for syphilis cases as well so we are hopeful on that but will continue to watch that as it may just be too early to tell or what is going on there.

Ms. Conover said that our Children with Medical Handicaps (CMH) program which is a case management program also helps on a larger scale by covering medical costs for families who have a child with a diagnosis and financial situation that makes them eligible which helps families maintain access to quality healthcare. She said that recently a piece of legislation was passed that extends care for CMH up to the age of 25 years for eligible children or individuals and we were thankful for that. She said that with this new legislation we will closely watch the caseloads because as we add eligible individuals to the caseloads other individuals who would have previously aged out will remain on the caseloads. She said that we are grateful for the hard work of our two (2) nurses that are the primary nurses working this program as they continue meeting with eligible families making good relationships.

Dr. King said that they now have a test for Lyme disease in dogs and they have seen a mild uptick in the number of positive results so it seems like we will likely see more people test positive as well. Mr. Shaffer said that we are seeing a lot of ticks and more specifically the black legged tick which carries Lyme disease. He said that we have been finding them here in Clark County for the last three (3) years. Dr. King said that in the past it was not something we worried much about but in the past 6-8 months we have seen at least one or two a month. Ms. Conover said that interestingly our report does show three (3) cases that meet the case definition of Lyme disease as opposed to zero reported this time last year and before the season is over, we may see more added.

Environmental Health: Mr. Shaffer said that the Ohio Department of Agriculture recently completed their survey of our food safety program and we had to write an action plan, which has been completed and submitted. He said that one piece in the action plan was enhancing our procedure related to inspections specifically what triggers a follow up inspection, enhance enforcement, and referral. He explained that follow up inspections are largely based upon the number and type of violations found. He said that we have reached out to other health departments to ask about their procedure and found a few that we like so we are working to analyze our inspection reports for violation averages and plan to reach out to current and former business owners as we consider recommendations for a procedure. He said that the new procedure may include a clean kitchen award as we do not to only be associated with corrective action. He said that we also want to be associated with rewarding businesses for running a good clean operation. He said that there is still a lot of work to be done but we wanted to share where we are going.

Mr. Shaffer said that we have had our first West Nile Virus positive in the mosquito samples. He said that we know from previous years that the West Nile Virus is endemic to the county as we find it everywhere in the county, but fortunately we do not have any positive human cases which is great news. He said that we reached out to the news media and use social media to make people aware and we have started spraying. He said that we decided not to concentrate only in areas where we found the West Nile Virus because we know that it is everywhere, so we are spraying in other neighborhoods and while notifying the public of the spraying we are reminding them that the best control is to get rid of standing water.

Mr. Shaffer said that the Clark County Fair starts this weekend, and we are promoting hand washing for improved health with signage, fair announcements, and hand wash stations. He said that more than sixty

(60) food vendors will be inspected by the end of the day tomorrow and we will work closely with Dr. King on anything zoological that may arise.

Dr. Robinette asked what is in the mosquito spray we use. Mr. Shaffer said that he does not know the exact ingredient, but the spray is Duet, and we buy it from Clarke. He said that it is important to note that mosquito spraying has no residual. He said that the mist only kills what is flying and is not harmful to humans. He said that the mist dissipates within a few minutes of spraying and is not harmful to humans, pets or wildlife and does not kill bees because it is not applied until dusk. Dr. Robinette asked if we have thought of implementing plants or wildflowers that repel mosquitoes. Mr. Shaffer said he does not believe that we have funding to do something like that on any mass scale that would be a benefit. He said that funding for the Duet is provided by a grant from the Ohio Environmental Protection Agency (OEPA). He said that this funding also pays for a summer intern to collect the mosquitos. He said that last year we received about \$21,000.00 in funding with about half going to product, 30% pays for the summer intern and the remainder pays for supplies and advertising.

Mr. Griffith said that anything we do to make the health inspection a more positive experience is a good thing. He said that educating food service operators about how to protect the public, encouraging positive behaviors, and not just finding what is wrong will be appreciated. Mr. Shaffer said that we appreciate the comments and anything we can do to better define our procedure will help set the standard for staff.

Early Childhood: Ms. Lambert said that after sharing last month that we were fully staffed one of our home visitors submitted her notice, so we have been reviewing applications and completed our first interview today. She said that we will continue to work on identifying the right person. She said that we had a family event on June 21, 2023, at the East High Street with outdoor games, indoor games, parachutes balls, sidewalk chalk, face painting, tummy time developmental games and snacks. She said that there were 98 attendees plus staff, so we had a great turn out. She gave a shout out to the staff for planning and executing such an excellent event. She said that we received a mini grant from the Young Women's Mission for \$125.00 which covered the cost of the event.

WIC: Ms. Thomas said that we recently hired two (2) part-time breastfeeding peer helpers who are currently finishing their training and at the end of May we hired a Dietetic Technician which does bring us back to being fully staff. She said that they are all a great addition to the team, and we are excited to have them on board. She said that we are preparing for breastfeeding awareness month also known as BAM in August but due to budget constraints, time commitments and our current caseload we will be promoting and celebrating in an alternate way. She said that instead of our annual one-day event we will be providing pregnant and breastfeeding moms with bags that contain breastfeeding information and support items when they visit the office throughout the month. She said that we have also designated a bulletin board in the lobby and the video playing with real moms and dads talking about breastfeeding.

Health Planning: Mr. Cook said that we have two (2) open positions in health planning and he and Ms. Gracie Hemphill have been interviewing over the last week and are getting very close to making some position offers. He said that we look forward to having a fully staffed health planning team soon. He said that Overdose Awareness Day is August 31, 2023, which is the largest worldwide recognition day, remembering those who have died, eliminating stigma, and acknowledging the grief of family and friends that have lost loved ones. He shared that this would culminate downtown with a Chalk the Walk event from 4:00pm to 7:30pm, which is something we have done multiple times in the past and it has been very successful. He said that families can write on the sidewalk and create drawings and graphics to remember some of their favorite memories of those that they have lost. He said that it is always a good, well-

attended event. He referred to graphics for the overdose awareness day t-shirt included in the board packet. He said that there was a contest to create the graphic and Mercy Reach had the winning submission. He said that staff and coalition members will be wearing the t-shirts at the end of August. He said that National Night Out for our first responders is coming up on August 1, 2023. He said that we will participate in this event through our safe communities program which will be held at Veterans Park. He said that this is always a well-attended great event, and we are looking forward to engaging the community and establishing those relationships between first responders in the community as we do every year. He said that we will have several of our health planners at the fair to interact with people, provide some very nice giveaways that highlight some of our programs, especially our lead program. He said that we will also be doing a tobacco community survey at our fair booth as well and look forward to getting some good responses from the community. He said that the lead grant was approved by the state of Ohio, and we will receive the full amount that we requested which is \$475,000 over the period of two (2) years. He said that we were excited to get the full amount we requested which will continue our funding here at little over \$237,000 a year.

Mr. Cook referred to the annual report from the Public Health Accreditation Board (PHAB) included in the packet. He said that as an accredited health department once a year we must submit what is called an annual report with about eight (8) different options to select the focus on the annual report. He said that this year he selected the fostering innovation option for the annual report. He said that this report shows what we submitted for our public health innovation process highlighting our Haitian Community Connection. He said that this idea came from Ms. Conover and has really flourished. He said that this has been one of the great things that we have created for our Haitian population that continues to grow every day and has become a think tank with the monthly meetings designed to first educate our community partners and agencies and then come up with ideas of what we can do to provide resources and options for routing people to those resources here in our community. He referred to PHAB's response and said they liked it, or you might say they loved it because they said this would be a great option to submit for required documentation when we go through the actual reaccreditation process in a couple of years, so we are very proud of that and the work that went into this from the entire team.

Dr. Robinette asked what we have seen as the biggest source of drug overdoses. She asked if we believe it is from people who are getting hooked on prescription medications or street drugs. Mr. Cook said much of the spikes that we saw in 2017 coincided with prescribed opioid use that escalated beyond that. He said that a lot has changed over the last few years when that was identified such as the number of pills that can be prescribed and tracking in the statewide database, so he believes those things have helped contribute but there are lots of other escalators such as cigarette smoking. He said that there are studies and evidence to show that people can escalate to marijuana and then more addictive drugs. He said that he cannot speak about what gets people addicted to substances like heroin and fentanyl as he does not have that data in front of him but believes that prescription drugs continue to be one of the gateways. Dr. Robinette asked if we had noticed it getting better or worse with all the free access to Narcan. Mr. Cook said that it is definitely saving lives. He said that he does not see any data or believe that the availability of Narcan has been a contributing factor and believes that it has done more harm reduction by saving people's lives. Dr. Robinette said that when looking at the numbers, she wonders if this is a concern that we will need to stay on top of. Mr. Cook said that he believes the numbers would be much worse without the availability of Narcan.

Vital Statistics: Ms. Hackathorne said that our low birth weight continues to rise and Ms. Kelly Stickney, our registrar, tracks our birth data and shared that our number of births is increasing as well with 125

births recorded for June. She said that included with the 125 births we had 21 Haitian and 17 Hispanic births.

Mr. Hackathorne said that our new health insurance rates went into effect on July 1, 2023, with our final annual cost coming to \$1.262 million. She said that we had anticipated between \$1.3 and \$1.35 million, but we had an increase in the number of non-enrollments and our high deductible participants increased from 18 to 26. She said that we did have twelve (12) staff stay on the PPO plan with two (2) of them being family plans.

Financial Report: Ms. Hardacre said that we recently wrapped up our grant reporting for the month and should be receiving payment soon. She referred to the transfers and advances that we requested last month and said those have not been completed by the Auditor's office so she manually put in those numbers to reflect what the current balance should be. She said that our State auditors have sent forms to each of the board members and asked that everyone take a moment to complete those forms and return them as soon as possible.

Legislative Update: Mr. Patterson said that the legislature is not in session at this time, so we do not have a report this month.

Vouchers: Ms. Hardacre presented the bills.

Transfers/Advances: Ms. Hardacre said that we are asking for budgeted advances from the General Revenue Fund to the Head Lice Prevention Fund in the amount of \$5,000.00 and to the HIV Fund in the amount of \$10,000.00 and an unbudgeted advance from the General Revenue Fund to the Haitian Community Connection Fund in the amount of \$75,000.00. She said that this advance will allow us to get some of our contractual expenses off the books, so we are not spending those towards the end of the year. She said once we receive this payment, which will likely not be until the end of the year, we will advance it back, but this will help us get those contracts in place and get the expenses off the books in a timely manner.

Public Comment: Ms. Donna Hodge thanked the board for allowing her to speak and Ms. Hackathorne for forwarding the documentation she sent to the board. She said that she is concerned about how the morality of this city is slipping. She advised that she moved here in 1994 because she thought that Springfield was the most perfect place but from what she is seeing now, she is glad that she is not raising children right now because of what they are being subjected to. She said that having the Pride event was one thing but the caliber of people and the indoctrination of the things she is seeing led her to start investigating. She asked if the board is aware that Planned Parenthood is indoctrinating children in a five (5) day camp at Clark State called “me”. She shared the website me.org and encouraged everyone to look it up. She said that this camp is for children ages 11 to 14 and the parent or guardian drops the child off at 8:00am and picks them up at 5:00pm. She said the camp runs July 31, 2023 through August 4, 2023, and no adult is allowed to stay which they state is due to security concerns. She said if the parent cannot stay because of security concerns why would you have children there in the first place. She said that she called Planned Parenthood of Southwest Ohio and they have already had their day camp in Dayton and Cincinnati. She does not understand how much sex education you can teach to children in 40 to 45 hours and feels it is ridiculous that we would subject our children to this camp. She said that her next aggravation is finding out where her tax dollars are going which is partly to us. She asked if the board knows that they are partnering with satanists- people like the Turner Foundation. She said that she will be forwarding another email to Ms. Hackathorne to share with the board next week about the satanist counseling being provided to children, teens, and adults by an individual from this foundation. She said that he has an office in Bellefontaine and was even a speaker at Satan Con 23. She asked if anyone knows about Satan Con which is their biggest gathering that was held at the Boston Marriott from April 28, 2023, through April 30, 2023. She advised that the individual responsible is Jack Legg and if look at the website showing what went on at this event you see things like women tearing pages from the bible. She said that she is even more outraged after seeing this because her property taxes and our property taxes are funding this organization. She said that she will be 81 years old in three (3) months and she is sick and tired of being duped. She said that we got duped during COVID, we were lied to, and people got rich from it. She said that we all need to wake up and look at what is happening in our city including the indoctrination of children. She said that she was stunned to see one lady posting on Facebook about tips that will help parents answer gender questions and we offer services such as this camp that is going to be happening at Clark State. She said that the agenda says it will have counselors but when she asked what happens if a child does not want to attend one of these sessions, she was told that they will be sent with another counselor. She thanked the board again for allowing her to speak and apologized for losing her temper. She said that she will be forwarding another video that shows young people dropping dead from strokes after being duped into getting the COVID vaccine. She shared that this affected her family after her husband’s cousin died of a stroke and the doctor classified it as COVID because they get money for that.

Special Report: Ms. Helain LeCaptain said that she was asked to investigate some data after the last meeting and wanted to share what she found. She referred to graph one (1) from the report included in

the board packet that shows Clark County death counts. She said that this is just in the first quarter of the year which is January through March for years 2017 through 2023 because we have only completed data for first quarter 2023. She said that the bar indicates the full death counts for each year and the orange portion shows deaths with COVID as the leading cause of death with blue being all the other causes. She said that for example last month it was pointed out that there was a large increase of deaths in quarter one of 2022 and then a drop in quarter one of 2023, but when you look at the historical data it shows more of a return to pre-pandemic death levels and this graph shows that the increase comes from deaths with COVID-19 listed as the leading cause of death. She referred to Figure 2 which is a continuation of that zooming in on the COVID deaths or deaths with COVID listed as a leading cause of death. She said that 23.4% of deaths in the first quarter of 2022 were COVID related deaths and then on the next page Figures 3 and 4 shows deaths from the entire year. She said that you can see a larger spike in 2020 to 2022 compared to previous years and a lot of that was due to the COVID deaths with 6% of the deaths in 2020, 10.6% in 2021 and 9.6% in 2022. She said that from the projections after the first quarter of 2023 the numbers are much lower. She said that she added the last part to give context to the data shared. She said that shows new reported cases, not deaths, but cases of COVID and you can see in that first quarter of 2022 there is a huge spike in number of reported cases which aligns with when we saw the larger number of COVID deaths.

Dr. Robinette asked how we define a COVID death. Ms. LeCaptain said that this data comes from the Ohio Data Warehouse which comes from death certificate data. She said that these are deaths with COVID listed as the leading cause of death. Dr. Robinette asked if we are saying that COVID caused the death, or the individual had COVID at the time of death. Ms. LeCaptain said that there are different ways to define it but, in this case, it is showing deaths with COVID listed as the leading cause of death on the death certificate. Dr. Robinette asked if she knows what that encompasses or how many of these people had pneumonia or other respiratory issues besides COVID because as she understands if you let a cold fester sometimes it can turn into double pneumonia which can ultimately lead to death. She said that knows a few people who started with COVID but were not treated properly and then they died due to pneumonia, but COVID was listed on their death certificate. Ms. LeCaptain said that in this case she did not pull just COVID data, she only pulled data that shows COVID as the leading cause of death. Dr. Robinette asked if "other" on Figure 3 encompasses all the other respiratory illnesses such as flu and RSV. Ms. LeCaptain said that is correct, it is other causes or anything that is not COVID. Dr. Robinette asked if we have done any studies in relation to these COVID deaths and how many people had the COVID vaccine and if they had the vaccine how many doses. Ms. LeCaptain said that the data she was able to pull from this specific data source comes from the death certificate which does have a lot of data, but their full medical history or vaccinations are not included. Dr. Robinette said that it is interesting that in year 2021 it was the highest and the vaccines started in late 2020 beginning of 2021 so she is curious to see if there is any correlation between that window. Ms. LeCaptain said that she is not immediately aware of any data about the correlation of deaths with the dates of vaccines.

Old Business:

Assessment of Nuisance Abatement Costs to Property Taxes for 2159 Duquesne Drive: Mr. Shaffer said that we hired Smith's to do the clean up with a roll off container and referred to photographs included in the board packet. He said that he cost was \$2,800.00 and he was able to negotiate with Springfield Township to cover half of that cost, so we are asking the board to certify the balance of \$1,400.00 to be assessed with taxes for the property.

Dr. Robinette asked if they had a chance to come in to represent themselves. Mr. Shaffer confirmed that we held the public hearing at the meeting last month and said that notices are posted at the residence as well.

R 63-23 WHEREAS, the Clark County Combined Health District Board of Health, at its May 18, 2023, meeting, declared the property at 2159 Duquesne Drive, Springfield, Ohio (Parcel #3000600003303035) a public health nuisance and ordered abatement of said nuisance; and
WHEREAS, the owner/occupants/heirs of the property located at 2159 Duquesne Drive, Springfield, Ohio failed to appear before the Clark County Combined Health District Board of Health at its May 18, 2023, and failed to promise to abate said nuisance; and,
WHEREAS, the Clark County Combined Health District Board of Health at its June 15, 2023, meeting and authorized to furnish material and labor and cause the work to be done;
NOW, THEREFORE, be it resolved that the itemized costs and expenses listed below be certified to the County Auditor.

Springfield Township Trustees, Reimbursement for Abatement – (\$1,400.00)

The cost shall be accompanied by the certificate of the President of the Board and attested by the Clerk of the Board that the cost amount is correct.

Beach Drive Nuisance Abatement Public Hearing: Ms. DeWitt opened the public hearing at 6:47p.m.

Mr. Shaffer said that some concerns citizens from the homeowner's association here tonight who will speak. He said that when he delivered the notice declaring the property a public health nuisance the owner was there and indicated that he had no interest in getting the property in order or following the public health order to abate the nuisance. He said that the owner, Mr. Chapman, did have a court date today in Municipal Court for driving under a 12-point suspension on his driver's license, which is his fifth offence driving without a license this year. He said that when he went by the property today to follow up it remained the same. Ms. Jill Bunnell said that she lives at Crystal Lake. She said that Mr. Chapman has all his junk and trailers on the property and many times the junk comes over onto her property. She said that they have had to clean up tires and shopping carts from the lake numerous times. She said that she received a call on July 13, 2023, that Mr. Chapman had parked a trailer on her property so she called the sheriff but was told by the sheriff that they could not have it towed because their property is private. She said that they told her that she could have it towed but would have to pay for the towing. She said that

he dropped a cylinder tank in their yard which sat there for a couple days so she called the Township and Ms. Nancy Brown came out and had the tank removed. She said that they have been fighting this for a couple years and if you approach him about it, he cusses at you. She said that they worry about the waste being dangerous for children in the area and the community and they should not have to live like this. She shared a letter from their board of trustees advising of their concerns. Mr. Shaffer explained that we do post notices from the Board of Health and Mr. Chapman commented to the deputies that he saw the notices and threw them out.

Hearing no questions or further comments, Ms. DeWitt closed the public hearing at 6:51p.m.

Variance Request – 4965 Willowdale Road: Mr. Shaffer said that the homeowners at 4965 Willowdale Road began construction on a building in the backyard and asked for a site review. He said that upon review we found that the building was too close to the trenches. He said that we are not sure how close because there was not enough soil, and we could not adequately probe up to the building determining where the trenches are and with the advent of the building any chances of a soil based secondary system for a replacement system similar to the last one was ruined so the homeowners are asking for a variance for the isolation distance from this leaching trenches to the building. Ms. DeWitt asked for staff recommendation. Mr. Shaffer said that they did not feel that it would negatively affect the system. He added that anytime a variance is granted the homeowner is obligated to disclose that to prospective buyers when the home is sold. He said that we always send variance requests to the Township Trustees to offer comments and we did get a comment back on this one from Trustee Kaffenbarger stating that he would support the variance request.

Possible Solid Waste Nuisance – 4457 Rebert Pike: Mr. Shaffer said that we received a complaint of solid waste accumulation at 4457 Rebert Pike last December. He said that he went out and noted that there was an accumulation and spoke with the homeowner, Mr. Dillinger, who advised that he was in the process of removing the material. He said that Mr. Dillinger indicated that he is disabled so to make extra money he picks up scrap material and it has just gotten out of hand. He said that he advised Mr. Dillinger that it seemed to be enough material to be a business and he did not disagree. He said that he explained the notice for the accumulation of solid waste would be sent to him and advised that we would recheck in 30 days. He said about a month later we did note that about half of the material had been removed but we noted he was doing illegal burning, so we sent a photograph to Regional Air Pollution as they handle enforcement of illegal burning. He said that he spoke with Mr. Dillinger over the phone on January 19, 2023, and he indicated that needed more time. He said approximately 30 days later February 22, 2023, upon follow up the property appeared to be about the same with no improvement so a second notice of violation was issued. He said that we did receive a call from a former Mad River Township Trustee indicating that he knew Mr. Dillinger and asked for more time so we explained that we would work with him. He said we laid off and did not go back until June, but the situation was not improved and looked to have more material. He said that he spoke with Mr. Dillinger, and he indicated that he did not feel it was

a problem. He said that he delivered another notice of solid waste accumulation last week and referred to photographs included in the board packet.

Mr. Dillinger said that there has been quite a bit of stuff removed since the photographs were taken a week ago. He said that something he does is help people who do not have the means to remove large items such as washers and dryers. He said that this keeps him busy and helps him as he lives off disability and that is not easy. He said that he does not believe this is a problem and feels the only thing that he is guilty of is it being an eye sore but does not see it as a health hazard. He said that he personally feels like there are much worse properties out there than his and said he could take us within a mile of his house and show us houses that are 10 times worse. He said that he feels pinpointed as prominent people in the community went out door to door to get people against him but do not do that for everybody which is not right. Ms. DeWitt assured him that it is not just him and the health district follows up on all complaints received. He said that he can show us a bunch of properties in worse shape where nothing is being done. He said that this all started because he spread out a 5-gallon bucket of material to sort through and some neighbors came across the street screaming at him. He said that it boils down to the neighbors being mad and he does not blame them because it is an eye sore, but he is working on it and tried to work throughout the winter which is not the best time and now it is either 100 degrees with sunshine or downpouring rain which is not great either. He said that if you drive by today, it looks better but he needs more time. Mr. Shaffer explained that the resolution drafted does have blank spots to allow the board to give him additional time to abate the nuisance and provided examples if they choose. Dr. Robinette asked Mr. Dillinger who is helping him. Mr. Tony Cooper said that he is Mr. Dillinger's cousin and he, his wife, his son, and others have been helping. He said that Mr. Dillinger is probably one of the nicest guys and his biggest fault is that he has a big heart. He said that he is always trying to help by buying shoes for the homeless or taking food to people who need it. He said that he admits that the property is an eye sore, but he does not see it to be a health hazard either. He said that they have been working to clean up the property from morning until dark and Mr. Dillinger does not need to be out there in the heat of the day, but he has been. He said that they may be able to finish it in 30 days, but 60 days would really be helpful. He said it is already looking much better. Dr. Robinette said her concern would be the air quality and whether they should be out there, specifically Mr. Dillinger if he is disabled so she is in favor of providing extra time. Mr. Dillinger said it is hard to be outside not so much in the heat but something with his medication makes it feel like his skin is boiling. Mr. Cooper said that the additional time would help as he also does not want to jeopardize anyone's health or life over metal. He said that he has been hauling material out daily and has not seen anything like animal carcasses or hazardous material.

Sewage Aerator Inspection Fees: Mr. Shaffer said that the way the Ohio sewage aerator rules are written those individuals or households that have a sewage aerator are required to have a service contract with a service provider to do regular maintenance and inspections and if they do not the rule authorizes us to do inspections and provide a written report to the homeowner requiring the aerator be fixed. He said that we have been presenting this list to the board for the last several years. He noted that the list has grown as one of our former staff members mistakenly crossed the homeowner off the list forever when they presented proof that they had a service contract, so we thought we were getting the list down and homeowners were getting on board with maintaining their aerators but unfortunately that was not the case. He said that we now have over 300 aerators that need inspections, and this list contains 61 households that did not pay for them. Dr. Robinette asked if the amount listed is our fee. Mr. Shaffer said that the \$56.25 is our fee plus the 25% late fee. Dr. Robinette asked if the homeowners would contact us to come out and do the inspection. Mr. Shaffer said that we have a list and we do inspections based on the list unless they notify us that they have a service provider.



COVID-19 monovalent vaccine

- Commercialization of COVID-19 vaccine as it becomes a vaccine that providers will buy from manufacturers and bill to insurance for payment
- Based on the totality of the evidence, for the 2023-2024 Formula of COVID-19 vaccines in the U.S., FDA advised manufacturers that they should develop vaccines with a monovalent XBB.1.5 composition.
- CCCHD is working with representatives from Moderna and Pfizer to find out the best pricing and way to make this available to clients. Part of the challenge is that the vaccine made by Pfizer requires an ultra-cold storage freezer if the vaccine is stored longer than 10 weeks.

RSV for adults 60 years or older




- RSV vaccine can prevent lower respiratory tract disease caused by respiratory syncytial virus (RSV).
- RSV can cause illness in people of all ages but may be especially serious for infants and older adults. Infants and older adults with chronic medical conditions like heart or lung disease, weakened immune systems, or who live in nursing homes or long-term care facilities, are at highest risk of serious illness and complications from RSV.
- Pfizer is the manufacturer of ABRYSVO. Glasco Smith Kline (GSK) is the manufacturer of Arexvy
- It can be billed under Medicare Part D (unlike flu and pneumonia) which makes the intake/registration part of this vaccine slightly challenging.

RSV (passive immunity) monoclonal antibody injection for infants:

- Beyfortus is made by drugmaker AstraZeneca in partnership with Sanofi.
- RSV infection rates typically rise in the fall and peak in the winter, but in 2022-23 season the started in June through November.






Tuberculosis Screening: IGRAs



Tuberculosis Screening: Chest X-Rays







Drug Overdose Prevention



One2One

- Second Harvest Food Bank (SHFB) Partnership: over the month of July, we gave out 42 food boxes to our clients.
- Sheltered Inc. Partnership: over the month of July, we completed 2 housing referrals.
- Department of Job and Family Services Clark County Partnership: over the month of July, we assisted 5 clients in completing applications for Medicaid and SNAP benefits.
- Needle Exchange stats from June 2023 (this data is always 1 month behind):
 - Client Visits: 200
 - Syringes Exchanged: 9,989
 - Narcan Kits Distributed: 129
 - Treatment Referrals: 4



Substance Abuse/DOP

- Overdose Awareness Day (OAD) is August 31st. OAD is the world's largest annual campaign to end overdose and remember those who have died without stigma and acknowledge the grief of the family and friends left behind. In partnership with the Clark County Substance Abuse Coalition, we have been planning an event to recognize the day locally. This year we will be hosting a "Chalk the Walk" event on August 31st from 4:00 to 7:30pm with a memorial walk beginning at 8:00pm at National Roads Commons. The event will also include:
 - Free Narcan and overdose prevention resources
 - A keynote speaker that will discuss stigma and the importance of harm reduction.
 - Social media campaign - during the month of August we will be posting information on harm reduction & stigma reduction on social media to raise awareness leading up to Overdose Awareness Day.
- We held a GROW (Get Recovery Options Working) Blitz on July 21st. GROW is an effort where volunteers canvas high overdose areas to provide overdose prevention resources to the community. Resources include treatment options, support group information, medicine disposal bags, and Narcan.
 - The results were as follows:
 - 70 Addresses were visited
 - 25 resources bags were distributed
 - 48 Narcan kits were distributed



Maternal & Child Health

- LifeSports camp kicked-off took place during the month of July at Clark State College. 28 youth participated partners with Springfield Promise Neighborhood and the Mental Health and Recovery Board of Clark, Greene, and Madison counties to put on the program. Pre and post camp survey data is being compiled and results will be shared on a future report.



Safe Communities

- Over the past month we have participated in several community events to increase community awareness on the dangers of distracted driving and seat belt usage for both teens and adults.
- National Night Out was held on August 1st. CCCHD/Safe Communities had a presence at the Springfield and Enon events.
- Safe Communities is currently planning a CarFit event that will be held on September 16th. The Carfit program for mature drivers during September. The Carfit program is designed to help older drivers find out how well they currently fit their personal vehicle, to highlight actions they can take to improve their fit, and to promote conversations about driver safety and community mobility. A proper fit in one's personal vehicle can greatly increase not only the driver's safety but also the safety of others.
- The Drive Sober or Get Pulled Over kick-off event will be held on August 11th from 4-6pm during the Springfield Jazz and Blues Feast taking place at National Road Commons Park.



Tobacco

- Continued to foster new partnerships throughout the community.
- Continued to distribute the Community Tobacco Survey to reach a goal of a minimum 300 respondents. 57 respondents as of 8/8.
- Attend Youth Empowerment Training in London, OH. Training provides an opportunity to learn strategies to increase youth involvement in prevention.
- Compliance checks of tobacco retailers in Clark County that fall outside the jurisdiction of Springfield's Tobacco Retailer License policy were completed in May/June. The results of those checks are presented here.

- Data collected from compliance checks can be used to gain support from decision makers for passing future TRL enhancements.

Creating Healthy Communities

- 🛡️ We purchased 750 bike helmets for the youth in Clark County. We will be giving these away at several different events over the summer gearing up towards walk/bike to school day in October. We were able to distribute many helmets at the Clark County Fair and National Night Out. We will continue to distribute helmets throughout the fall.
- 🛡️ Currently working on putting together a nutrition policy with Second Harvest Food Bank. The board approval process has started. Hopefully this will be implemented by the fall.
- 🛡️ We attended the July Clark County Local Foods Council meeting. The focus of these meetings is to provide support and capacity building to local community gardens. Each meeting is held at a different garden site.
- 🛡️ The continuation grant application for Creating Health Communities was submitted on July 31st.



Lead

- 🛡️ Attended the Clark County Fair from July 23-30th. Lead safe literature as well as give aways were passed out each day.
- 🛡️ Presented to Neighborhood Housing Partnership's Homebuyer education class on 7/25
- 🛡️ Met with LAMAR on 7/11 to discuss future placement of billboards, designs, and changes, where each billboard is and how we will proceed in the next few months.
- 🛡️ Met with the organization, People Working Cooperatively Home Repairs, to discuss local lead and Healthy Homes Collaborative in Hamilton County and how what they are doing in Cincinnati could be implemented in Clark County.
- 🛡️ Received notice that the abatement project for 350/352 W State Street property will begin on August 15th. The contractor estimates the work will take approximately two weeks.

Additional Updates

- 🛡️ The Health Planning team welcomed a new member, Amari Bradford, on August 7th. Amari will be working in both the Tobacco and Lead programs.

The [Public Health Fund of Ohio](#) (PHFO) was created in July 2020 to support the mission of the Ohio Department of Health (ODH): “to advance the health and wellbeing of all Ohioans” and to support the State Health Improvement Plan (SHIP).

The PHFO is a Type I supporting organization to the Greater Cincinnati Foundation (GCF) and managed by the staff of the HealthPath Foundation, another supporting organization of GCF. PHFO is governed by a seven-member board of directors, appointed on February 28, 2022.

The vision for the creation of the PHFO was to facilitate public/private partnerships and conduct critical, enduring, sustainable, and cost-effective public health projects and programming. The PHFO issues grants and conducts work related to the enacting legislation:

- Conduct public health awareness and educational campaigns
- Implement and administer innovative public health program and prevention strategies
- Address priority public health issues
- And conduct other work related to advancing positive changes in population health in Ohio.

ELIGIBILITY

County Selection Methodology

The following methodology was used to select Ohio counties eligible for a grant of up to \$50,000 per year for two years.

The measures below were used to identify counties in the upper quartile. For each measure, points were assigned to each county in the upper quartile.

Deaths (10-24 Years):

2017-2021

2.5 pts (points given if ranked in the upper quartile of counties with highest rate)

Percent Change in 2012-2016 vs. 2017-2021 Deaths (10-24 Years):

2 pts (points given to counties with a percent increase of 50% or more)

Suspected Suicide Attempts (11-24 Years):

2021

1 pt for rate (points given if ranked in the upper quartile of counties with highest rate)

2022

1.5 pts for rate (points given if ranked in the upper quartile of counties with highest rate)

2020 Social Vulnerability Index:

2.5 pts given for high SVI (.7501+)


1.5 pts given for medium-high SVI (.5001 - .7500)

TOTAL POSSIBLE = 9.5 Points

Using this methodology, a maximum of 9.5 points could be assigned to each county. Counties were ranked based on the number of points assigned. Twenty-seven counties became eligible: Ashland, Ashtabula, Athens, Clark, Coshocton, Cuyahoga, Darke, Gallia, Geauga, Greene, Hamilton, Highland, Huron, Lake, Licking, Logan, Lucas, Montgomery, Muskingum, Pike, Scioto, Shelby, Stark, Summit, Tuscarawas, Union, and Wayne.

Public Health Fund of Ohio Youth Suicide Prevention Counties Eligible to Apply



This funding opportunity is specifically targeted for the twenty-seven Ohio counties listed above. Eligible applicants and their fiscal agents are the Suicide Prevention Coalitions listed on the Ohio Suicide Prevention Foundation's [website](#). A fiscal agent for the coalition must be a local government agency, school district, college or university, or a nonprofit 501(c)(3) organization in the county. This funding opportunity is intended to compliment the Suicide Prevention Plan for Ohio.

SUGGESTED STRATEGIES, APPROACHES, AND RESOURCES

The Centers for Disease Control and Prevention (CDC) highlights strategies based on the best available evidence. The strategies and approaches below are eligible for funding and are promoted in the Ohio Suicide Prevention Foundation's Plan <https://www.ohiospf.org/wp-content/uploads/2023/01/OSPF-2021-Report-Final.pdf>. Some populations in Ohio have worse outcomes around suicide according to the Health Policy Institute of Ohio, 2023 Health Value Dashboard. For example, LGBTQ+ Ohioans have 4.8 and 4.3 times worse outcomes in youth considering suicide and youth suicide attempts. Please consider developing programs/responses to these and other at-risk populations.

- Strengthen household financial security
- Stabilize housing

Lessen Harms and Prevent Future Risk

- Intervene after an attempt (postvention)
- Report and message about suicide safely

Improve Access and Delivery of Suicide Care

- Cover mental health conditions in health insurance policies
- Increase provider availability in underserved areas
- Provide rapid and remote access to help
- Create safer suicide care through systems change

Identify and Support People at Risk

- Train gatekeepers
- Respond to crises
- Plan for safety and follow-up after an attempt
- Provide preventive therapeutic approaches

Create Protective Environments

- Reduce access to lethal means among persons at risk of suicide
- Create healthy organizational policies and culture
- Reduce substance use through community-based policies and practices

Teach Coping and Problem-Solving Skills

- Support social-emotional learning programs
- Teach parenting skills to improve family relationships
- Support resilience through education programs

Promote Healthy Connections

- Promote healthy peer norms
- Engage community members in shared activities

Limitations

Services not funded under this opportunity include all clinical, medical, therapeutic, and treatment-based service modalities. Only prevention service will be funded under this opportunity. For the purpose of this RFP, prevention is defined as the delivery of services or strategies prior to the onset of a disorder. These interventions are intended to prevent or reduce the risk of developing behavioral health problems, such as underage alcohol use, prescription drug misuse and abuse, illicit drug use, and mental illnesses.

Funding and Project Dates

The PHFO RFP opening date is June 1, 2023 and the deadline for application submission is September 1, 2023. This extended timeline should provide ample time for communities to collaborate on the prevention strategies that will benefit the community. A total of \$300,000 is available for distribution to approximately six to twelve counties/coalitions. The maximum amount per county/coalition is \$50,000. The same amount of funding will be available for a second year based on reporting and outcomes.

Application

The deadline for receipt of the application for funding is no later than 12:00 noon on Friday, September 1, 2023. The application must be submitted through our [online application portal](#).
