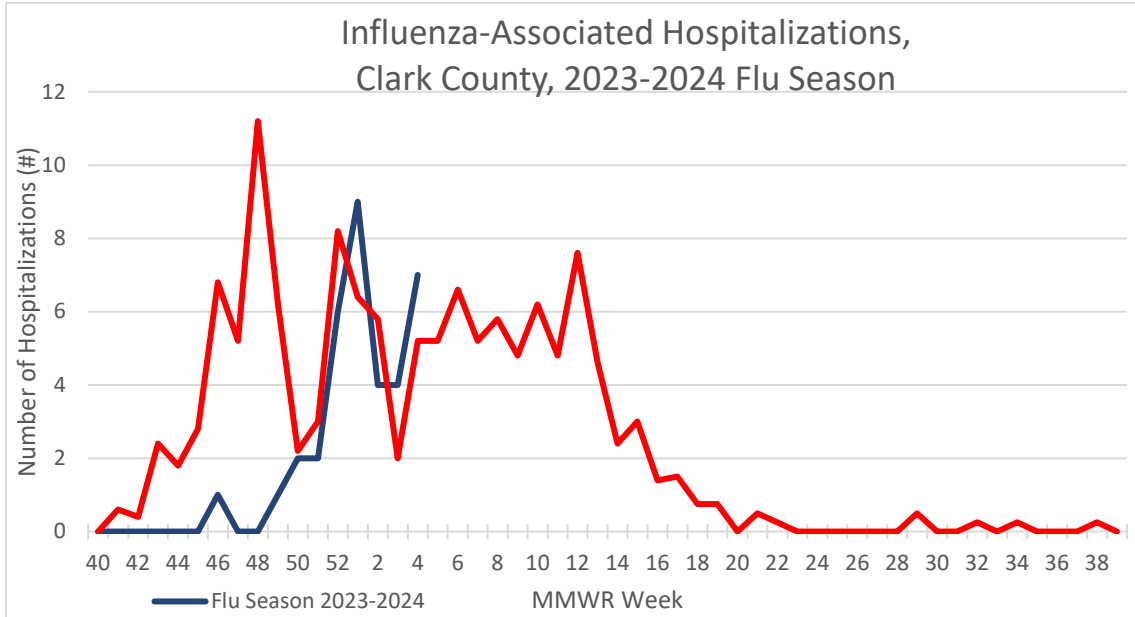




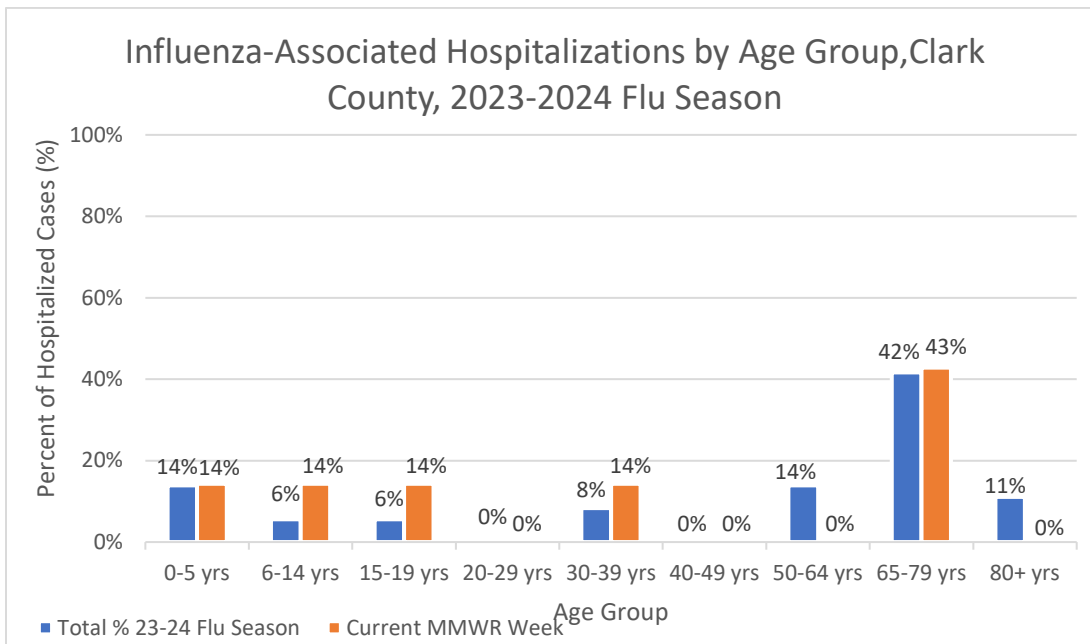

## Clark County Influenza-Associated Hospitalizations and ED Visits Report

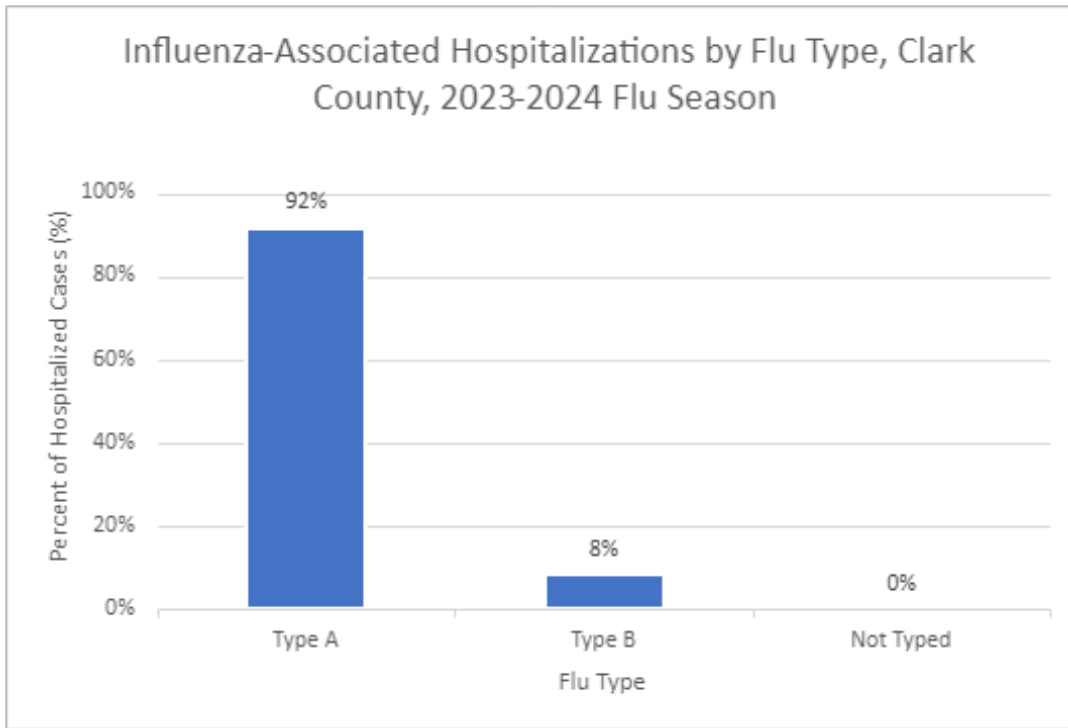
2023 MMWR Week 40 ended on October 7th. This is considered the beginning of “flu season.”



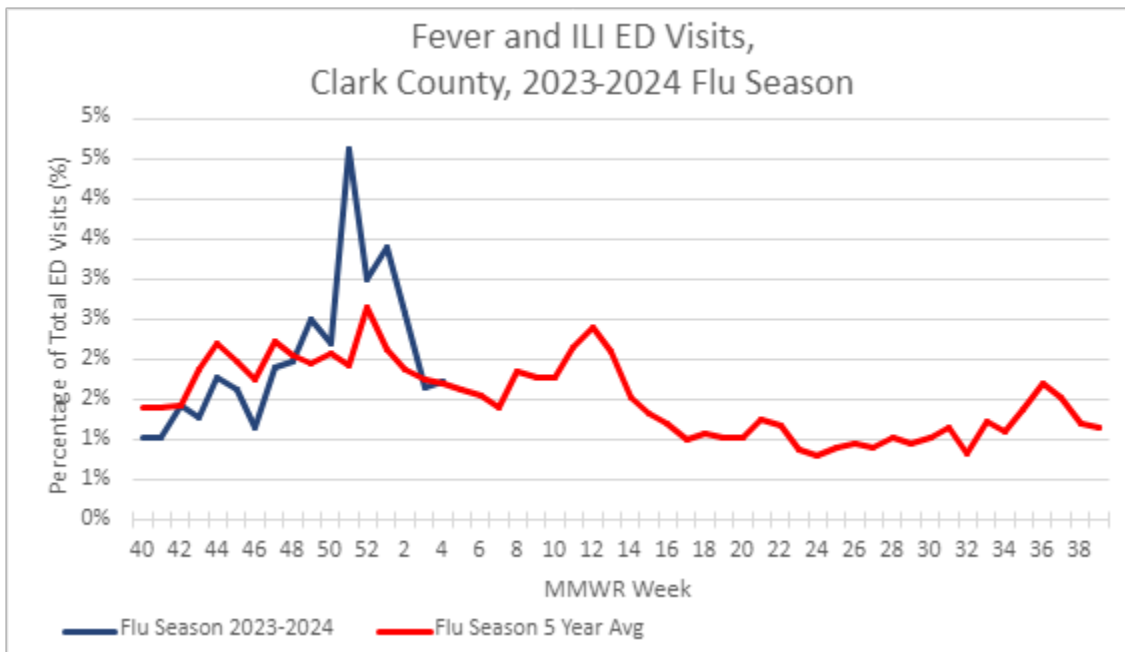
**Figure 1:** Influenza-associated Hospitalizations in Clark County, OH; 2023-2024 flu season compared to 5-year average. Data queried from Ohio Disease Reporting System (ODRS) Data Extract on 1/31/2024. These are preliminary numbers and may change based on updated ODRS data.



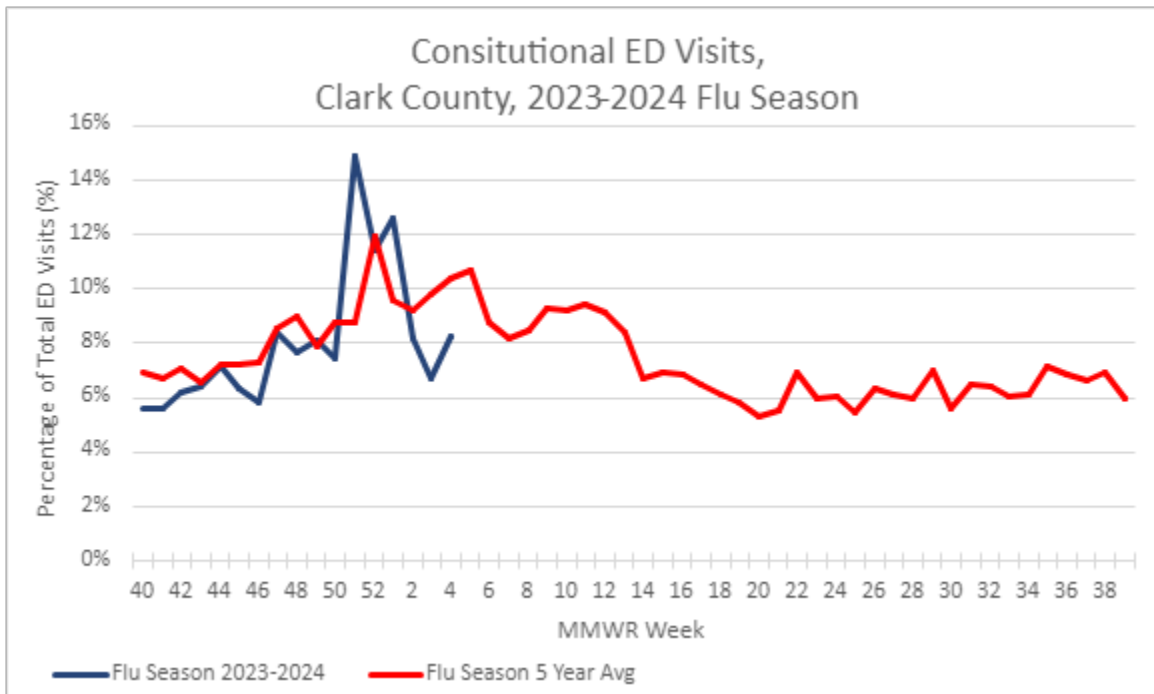
**Figure 2:** Confirmed Influenza-Associated Hospitalizations in Clark County, by age group. MMWR Week 40 – 14 (10/1/2023 –4/6/2024). Data queried from ODRS Data extract on 1/31/2024.

### National Influenza Summary: MMWR Week 3 (Jan 14th – Jan 20th)

This week, 5 jurisdictions experienced very high activity and 17 jurisdictions experienced high activity. Ohio was a state that reported high activity.

There have been 57 Pediatric Deaths reported this flu season for influenza associated deaths.

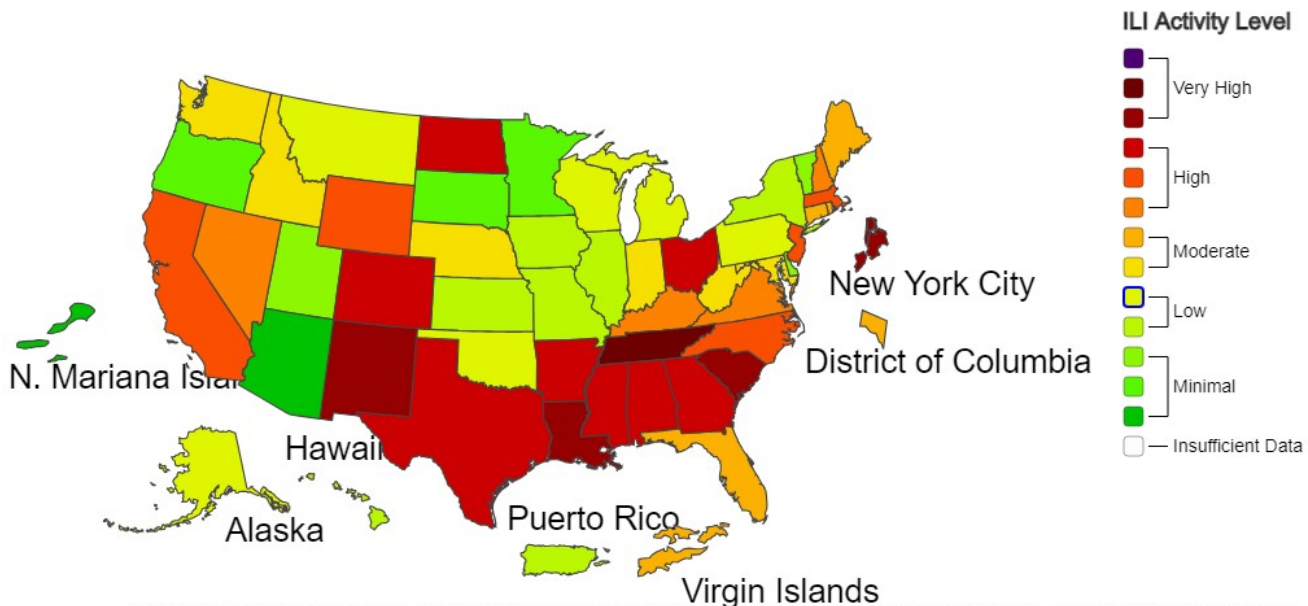


## A Weekly Influenza Surveillance Report Prepared by the Influenza Division

### Outpatient Respiratory Illness Activity Map Determined by Data Reported to ILINet

This system monitors visits for respiratory illness that includes fever plus a cough or sore throat, also referred to as ILI, not laboratory confirmed influenza and may capture patient visits due to other respiratory pathogens that cause similar symptoms.

\*This map uses the proportion of outpatient visits to healthcare providers for influenza-like illness to measure the ILI activity level within a state. It does not, however, measure the extent of geographic spread of flu within a state. Therefore, outbreaks occurring in a single city could cause the state to display high activity levels.

\*Data collected in ILINet may disproportionately represent certain populations within a state, and therefore may not accurately depict the full picture of influenza activity for the whole state.

\*Data displayed in this map are based on data collected in ILINet, whereas the State and Territorial flu activity map are based on reports from state and territorial epidemiologists. The data presented in this map is preliminary and may change as more data is received.

\*Differences in the data presented by CDC and state health departments likely represent differing levels of data completeness with data presented by the state likely being the more complete.
