### **JOB SUMMARY**

The Communicable Disease Nurse Supervisor investigates communicable disease reports and implements public health strategies in accordance with the Ohio Infectious Disease Control Manual (IDCM). Collaborates with healthcare providers, environmental health staff, and community partners to support disease surveillance, education, and prevention efforts. Participates in regional and state epidemiology activities to strengthen response and coordination. The Communicable Disease Nurse Supervisor is also responsible for providing health screenings and tuberculosis testing as applicable while ensuring accurate documentation and client education. Follow all public health guidelines, maintain HIPAA compliance, and uphold safety protocols for bloodborne pathogen exposure.

### **EDUCATION & QUALIFICATIONS**

Must hold a current, valid Registered Nurse license in the State of Ohio. Requires a Diploma, Associate, or Bachelor of Science in Nursing from an accredited nursing school; BSN and public health nursing experience preferred. Must have a valid Ohio driver's license with state minimum insurance, an acceptable driving record, and current CPR certification. Must complete the CDC's Nursing Home Infection Prevention Training course within one (1) year of hire.

- Investigate communicable disease reports following the Ohio Infectious Disease Control Manual (IDCM) and implement appropriate public health interventions to prevent transmission
- Utilize the Ohio Disease Reporting System (ODRS) and related databases to document infectious disease cases, maintain investigation and treatment notes, and ensure timely, accurate reporting
- Collaborate with local health district staff, healthcare providers, laboratories, and other partners to support disease surveillance, education, and prevention efforts

- Coordinate with environmental health staff on disease contact investigations related to food, water, or vector-borne illnesses
- Participate in planning, training, and response activities at the local, regional, and state levels; maintain effective relationships with public health partners
- Maintain required records and reports in compliance with the Health District and grant requirements;
  assist in developing protocols and the epidemiological response plan
- Provide education to healthcare providers and the public on infectious and reportable diseases, including in-service training on communicable disease topics
- Participate in testing and vaccination efforts, including collecting specimens via phlebotomy and conducting home or field visits for contact tracing and treatment
- Oversee and case manage both active and latent tuberculosis (TB) cases, including Directly Observed Therapy (DOT), under physician supervision; report and track data as required by ODH
- Provide supervision and support to Public Health Nurses working in the TB clinic and assist with lab collection as needed
- Serve as a subject matter expert on tuberculosis, supporting community healthcare providers in assessment and treatment
- Promote health and prevent disease through education in clinics, homes, schools, and community settings; deliver group presentations and participate in public outreach activities
- Ensure compliance with HIPAA, safety procedures for bloodborne pathogens, and public health laws and guidelines; respond to client and provider inquiries and coordinate care services across agencies

Participates in agency disaster preparedness activities; may be required to report for work outside normal working hours during an emergency; available 24/7 for consultation related to bioterrorism/public health emergencies; meets all <u>public health core competencies</u> as outlined by the position's Supervisor; completes other duties as assigned.

### **KNOWLEDGE, SKILLS, AND ABILITIES**

Detail-oriented with strong organizational and documentation skills, Ability to successfully complete N95 fit testing upon hire and operate while wearing a fit tested N95 (for higher) respirator as required, Proficient in the use of computers, databases, spreadsheets, and various software applications; able to troubleshoot and seek support for office and medical equipment, including phones, copiers, faxes, scanners, and lab instruments, Must possess a valid driver's license and be able to operate a motor vehicle for fieldwork and home visits.
