Board of Health Meeting Minutes
June 18, 2025

Vice President Scott Griffith called the June 18, 2025, Clark County Combined Health District Board of Health meeting to order at 6:00 pm.

Board members present: Dr. John Gullledge, Dr. Sherry Robinette, Dr. Bernadette deGuzman, Dala DeWitt, and Scott Griffith.

Board members absent: Dr. Valerie Moore and Mike Adamson.

Ms. DeWitt motioned to adopt the June 18, 2025, agenda and Dr. deGuzman seconded. The motion passed unanimously.

HSTS Variance Request: 1039 Willow Road: Zibby referred to the variance application included in the board packet. She said that the Ohio Administrative Code (OAC) requires that a sewage treatment system maintain a minimum horizontal isolation distance and in this case the homeowner desires to build an addition to the rear of their existing structure that will be less than 10 feet from their septic tank. The homeowner, Mr. Gerrich, introduced himself and said that when he completed the variance application, he noted a 5-foot distance but determined that it is 7 feet. The proposed addition is not a load bearing wall, but rather a facade with a footer block. He said the primary load-bearing elements will be located on the east and west sides, with the trusses. Zibby said that our primary concern is the potential risk of damaging the septic tank during the construction processes, including the moving of equipment and materials, however, the homeowner will sign a hold harmless agreement if the variance is approved.

R 58-25 A resolution **approving** a household sewage treatment system rules variance at 1039 Willow Rd., Springfield, Ohio (Parcel # 2200300028200014) allowing an addition to be installed in a location that is less than 10 feet from the household sewage treatment system with the responsible party signing a Hold Harmless Agreement.

Possible Public Health Nuisance: 9410 Milton-Carlisle Road, New Carlisle: Zibby said that this property is in Bethel Township just outside of New Carlisle. We have received multiple complaints dating back to 2020, and despite multiple orders, the property owners have failed to comply. The orders pertained to solid waste dumping and improper storage, improper storage and parking of vehicles, trailers, boats, junk vehicles, burning of unknown potentially hazardous materials, and suspected kennel operation with the presence of live animals in the kennel. Zibby said that the County Building and Zoning Department has also received multiple complaints regarding the property. However, we have been unable to gain access as the homeowner has a gate near the road and the house sits back off the road. She noted that we can see some solid waste from the road and shared photographs including ariel photographs from a drone shared with us by the building department. We have communicated with the homeowner requesting access to the property and a meeting; however, they have not granted us access to get closer to the property. Chris added that we have provided the homeowners with several opportunities, but they have failed to take any action, which is why we are asking the board to declare this a public health nuisance with hopes of seeing some movement. Dr. deGuzman asked what happens to the animals in the kennel. Zibby said that they have not seen animals, but we have received complaints from neighboring properties indicating the presence of animals which we referred to the Humane Society and SPCA. Zibby said that she talked with the homeowner again yesterday requesting access to see the property and was advised that they do not allow people on their property due to the animals and fear that people may bring diseases to them. Dr. Robinette asked if we have the authority to do something about the nuisance without violating the rights of the homeowner. Chris confirmed that we have multiple complaints from several different neighboring property owners and explained the state and local laws that allow for the governance and abatement of nuisances giving us the board the authority to declare a public health nuisance which does not violate their rights as property owners. Zibby noted that the homeowners were provided notice that this would be brought before the board this evening and invited to attend.

Possible Public Health Nuisance - 2760 York Street, Springfield OH: Zibby said that this property is in the Limecrest subdivision of Springfield Township, just on the south end of Springfield. She referred to photos displayed on the TV screen, saying that there have been multiple mattresses, a couch and other furniture scattered around the lot and that we are asking the board to declare the property a public health nuisance. The property owner, Mr. McAfee, introduced himself and said that he has been working to clean the property up and showed photographs dated today of the property with most of the solid waste removed. Mr. Griffith asked Zibby if there would be a follow-up inspection should the board decide to table the agenda item, and she confirmed that the environmental team would follow up on Friday to verify the solid waste has been cleaned up.

Ms. DeWitt motioned to table the agenda item for follow-up at the next meeting. Dr. Robinette seconded the motion. The motion passed unanimously.

Contracts – Interpreters, Clark County ESC: Chris said that this agreement is a continuation for interpreter services through the Clark County Educational Service Center.

Contracts – High Street Building Lease, Community Health Foundation: Chris referred to the addition to the board packet which is the proposed lease for the High Street location with the Community Health Foundation. He explained that this is an agreement to occupy the location for at least another five (5) years with the option to renew for another five (5) years after that. The agreement holds the rent at the same price for five (5) years with a 3% increase in year six (6) that would carry through year ten (10). He said that we cover the utilities and a portion of their fire and casualty insurance and per the agreement any cost for repair or replacement of the roof, HVAC, and sidewalks will be a 50/50 split.

He said that our agreement with the county is that we will pay the cost, and they will reimburse us 50%, so our total cost will be just over \$11,000.00. Monthly Fund Report: Jeff reviewed the monthly revenue and expenses as well as the summary budget. He said that he is starting to meet with the program heads to ensure that he provides accurate and timely data and asked the board to let him know if there is any additional data or reports they would like to see each month.

PUBLIC HEALTH TEAM REPORTS

Environmental Health: Zibby said that as we enter peak season for outdoor gatherings and events, our environmental health staff are busy inspecting food vendors at festivals, farmers markets, and fairs to ensure compliance with food safety regulations. She thanked the team for tireless efforts in working closely with food vendors to minimize the risk of foodborne illnesses. She said that their dedication and hard work throughout the year, not only in the food program but also in their overall responsibilities are truly appreciated.

Zibby reminded everyone that as we enjoy the warmer months, it is also essential to remain mindful of the potential health risks associated with mosquitoes and tick-borne diseases. She said that despite not being awarded the mosquito surveillance grant, we continue to remind the community to take precautions such as wearing long-sleeved clothing, long pants, and EPA-approved insect repellents, even on hot days, to minimize the risk of transmission.

Nursing and Clinics: Cheyenne said that we are seeing a lot of people in our clinics and the nurses are working hard with outreaches including blood pressure screenings at Groceryland, blood pressure and sodium education at United Senior Services and the Spring Fling at Hayward Middle School to provide education on sexual health and wellness.

Early Childhood: Lori said that Help Me Grow funding was previously allocated as a block grant to each of the 88 counties by the Ohio Department of Health. However, approximately ten (10) years ago, the funding model for Help Me Grow Home Visiting was transitioned to a billable model and the funding for Help Me Grow Early Intervention and Service Coordination through Developmental Disabilities remained unchanged as a block grant. She explained that this means that services provided, including home visits, are now billed to the appropriate parties, similar to the home health care model. She said that approximately thirteen (13) years ago we successfully applied for and have since been maintaining a Maternal Infant Early Childhood Home Visiting federal grant, known as MIECHV. She said that this block grant funding has provided us with necessary resources to sustain the program for the past 13 years, with a total of \$482,460 allocated for the current year. She said that recently the Ohio Department of Children and Youth decided to shift the federal funding to a billable model which is effective July 1, 2025. As a result, all services provided to families will not be subject to billing. She said that this change may pose some administrative challenges, particularly for home visitors, supervisors and herself, as payments will not longer be received in the form of a block grant, but they are committed to ensuring a seamless transition and will together to overcome any challenges that arise.

Women, Infants & Children: Emily said that the total caseload for Springfield and New Carlisle have been consolidated which allows for better staff efficiency while operations at the New Carlisle clinic remain paused. She said that they were pleased to participate in the recent kickoff event for the farmers market, and thanked Amanda Cogburn for leading our participation by providing essential program information.

Emily said that they received unfortunate news regarding the farmers market vouchers being significantly reduced. She said that this cut is disappointing, but they are exploring other options to be able to provide vouchers to more participants and remain hopeful that they will receive another round of vouchers in the future.

Health Planning: Gracie highlighted two (2) initiatives with the first being the Adolescent Health Program hosted sports camp, which is open to students in grades 5th through 8th. Registration for this program is now open, and it will take place during the month of July. This program offers a unique opportunity for campers to learn sports skills while also developing essential life skills. She said that they have partnered with Springfield Promise to provide meals and snacks for participants. She next highlighted the new bike-share program, launched in partnership with the Clark County Public Library. This program, under the Creating Healthy Communities initiative, aims to promote a healthier, more active lifestyle among the community. She noted that this program will feature seven bicycles, helmets, and bike locks, which can be rented or checked out by library patrons. She said that they are excited about this new initiative and hope that it will be well received by the community.

Gracie noted that they received some concerning news regarding the state budget and that unfortunately, the contract for the Lead Safe Home program is under threat due to the removal of the funding from both the House and Senate budget versions. She said that this funding was crucial for education and awareness efforts, workforce development, and prevention programs. She said that despite this loss they are committed to continuing their education and awareness efforts and will continue to work with lead abatement contractors to integrate their expertise into other programs. She said that the news is devastating but they are determined to find alternative solutions and ensure that our community remains protected from the risks associated with lead exposure.

No Special Report

Legislative Update & Health Commissioner's Comments: Chris said that the Medicaid and Administrative Claiming "MAC" fund provides reimbursement to local health departments for administrative activities that do not fall into the category of billable services in a clinic. He said that this program has been instrumental in helping with capital improvements or repairs as we do not have a capital improvement stream of income. He said that recently we added additional staff which almost doubled our reimbursement amount in the last quarter. He said that regarding legislative updates, the Association of Ohio Health Commissioners (AOHC) has been closely monitoring the state budget and federal funding. The reduction in the chronic disease management fund is a significant concern, and they are working to understand the implications of this change. He said that we were also notified that our emergency preparedness grant will be reduced, but we are hopeful that alternative funding sources will be explored. He said that there have been developments at the state level, including the introduction of HB 272, which aims to remove certain additives from food products and includes provisions for the addition of fluoride to water in certain communities. He said that there have been proposals at the state and federal levels that could have significant implications for our community. HB 335, for example, would eliminate or drastically change property taxes in Ohio, and they are working to understand the potential implications of this bill.

He said that the AOHC are committed to continuing their work in public health, regardless of the challenges faced, because they know that prevention is key, and will continue to prioritize this approach.

Chris thanked Dr. Gullledge for his service to the board and the community. He said that we appreciate the valuable perspective he brought to our discussions.

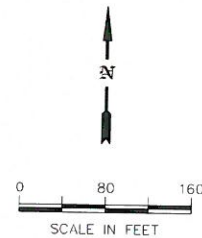
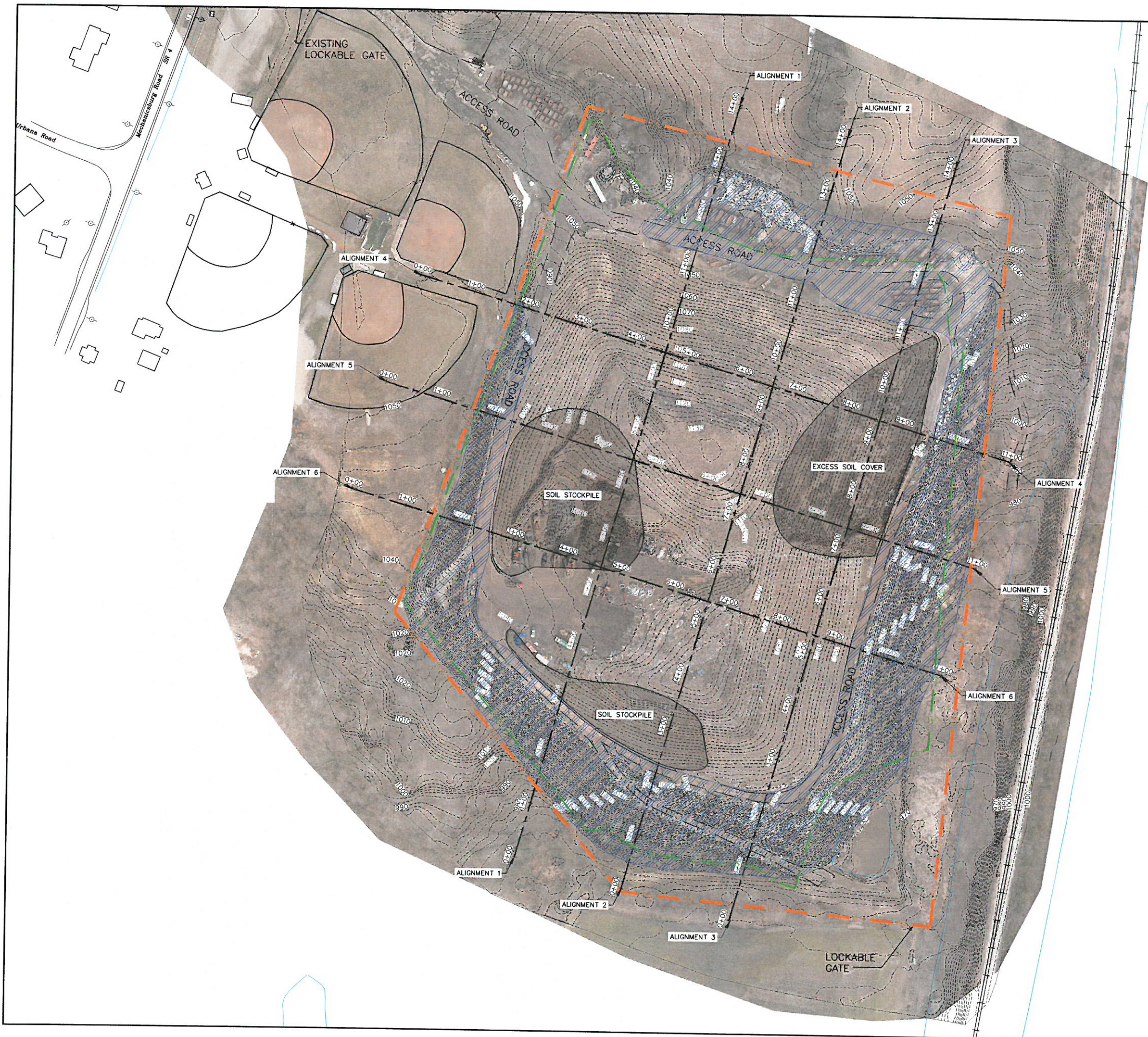
Additional Business

PURPOSE

- Creating a drug and tobacco-free environment protects employees and the public from the harms of drug use and secondhand smoke. Drug/tobacco-free environments encourage people to quit, prevent initiation of tobacco use by youth, and limit exposure to secondhand smoke.
- This promotes the health and safety of Clark County Combined Health District (CCCHD) clients, visitors, and volunteers by establishing a 100% tobacco and drug-free campus.

Scope

- This policy applies to all persons on all properties owned, leased, or operated by the Clark County Combined Health District. The policy is in effect 24 hours a day, seven days a week.

DEFINITIONS

1. **Smoke and smoking** –Inhaling, exhaling, burning, or carrying any cigarette, cigar, electronic or non-electronic smoking device, pipe, hookah or other product or substance; or any other smoking of tobacco, nicotine, plant or substance, whether natural or synthetic, in any manner or in any form.
2. **Tobacco** – Any product that contains tobacco or nicotine that is intended or expected to be introduced into the human body, including any cigarette, cigar, pipe, electronic or non-electronic tobacco product, or any other smoked or smokeless tobacco product, excluding any product that has been approved by the FDA for tobacco cessation or other medical purposes.
3. **Drug**- Any substance that changes or affects the way the body or mind works and is not used legally or as prescribed. This includes illegal drug (e.g. cocaine, heroin), marijuana, prescription drugs used without a prescription or not as directed, and any substance used to get high.
4. **Tobacco and Drug Free** – Smoking or using of tobacco, tobacco- like products, nicotine, plant or substance, or any other drug, whether natural or synthetic, in any manner or in any form is prohibited.

POLICY

- Smoking and tobacco products must be extinguished and properly disposed of prior to entering CCCHD property or exiting personal vehicles. Improper disposal includes, but is not limited to littering package waste, discarding cigarette butts, throwing cigarette butts out of windows, or any littering that may create a health, safety or fire hazard. No ashtrays or smoking shelters will be provided on CCCHD grounds.
- The sale, promotion, or distribution of smoking, drug, or tobacco products and merchandise is prohibited in and on all CCCHD owned and occupied properties.

Communication

- Signs stating the CCCHD's drug and tobacco-free campus policy will be clearly posted on the perimeter of the property, at driveway entrances, and in other prominent places.
- Employees, clients, visitors and the community will be informed of the policy through a variety of communication methods, e.g., website, appointment reminders, newsletters, signage, print and electronic media, meetings, and other communication materials.

Compliance and Enforcement

- All CCCHD employees are authorized and encouraged to communicate this policy with courtesy and respect. It is a shared responsibility of all CCCHD employees to see that this policy is followed.
- Individuals acting in violation of this policy will be informed or reminded and asked to comply. Individuals who refuse to comply with this policy should be reported to a supervisor and may be asked to leave.
- Any CCCHD employee found to have violated this policy may be subject to disciplinary action outlined in Appendix 4 of the personnel policy.

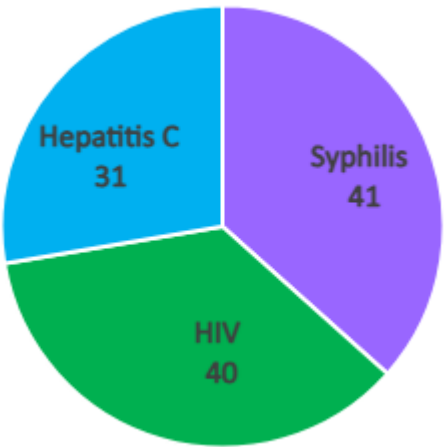

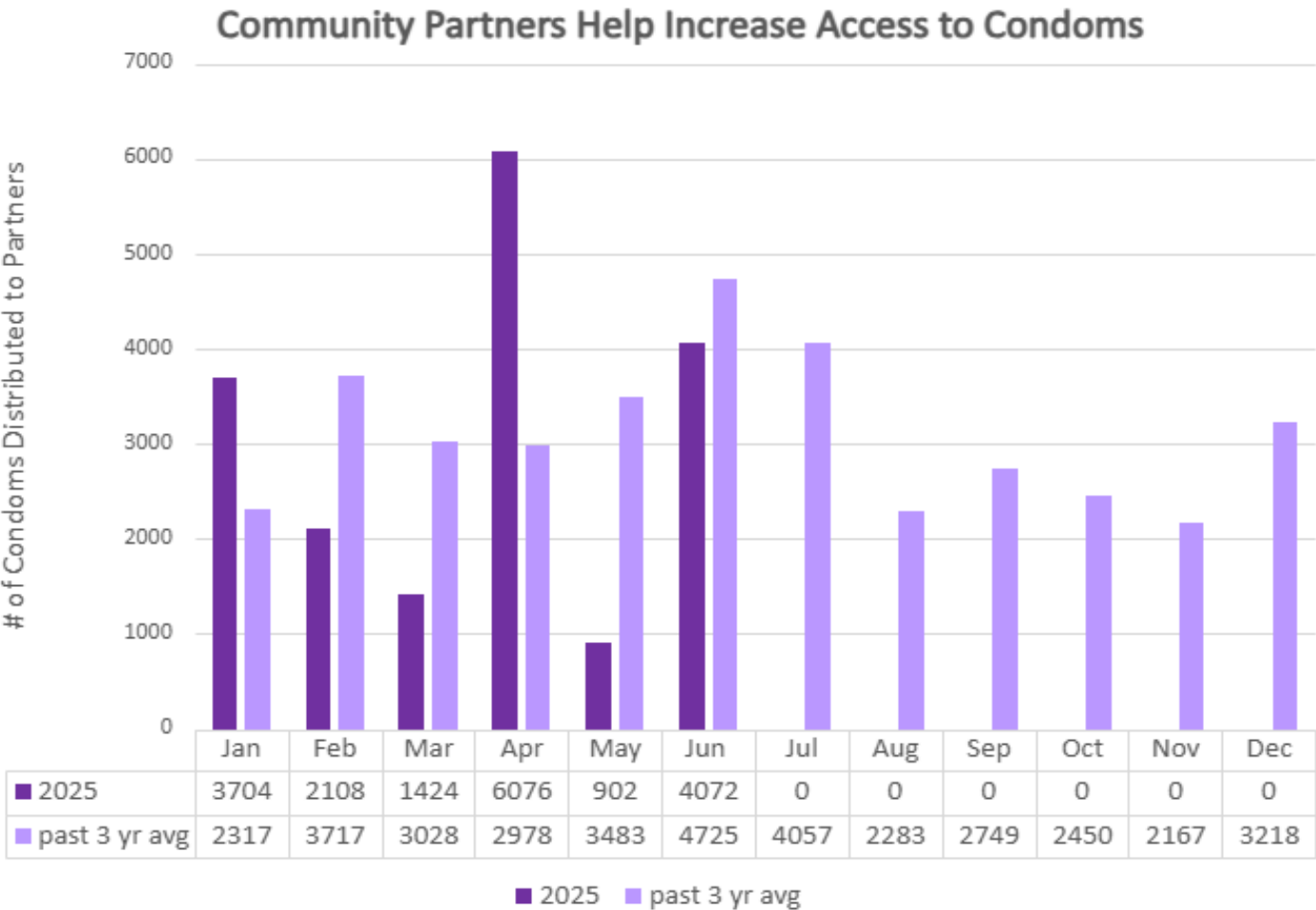

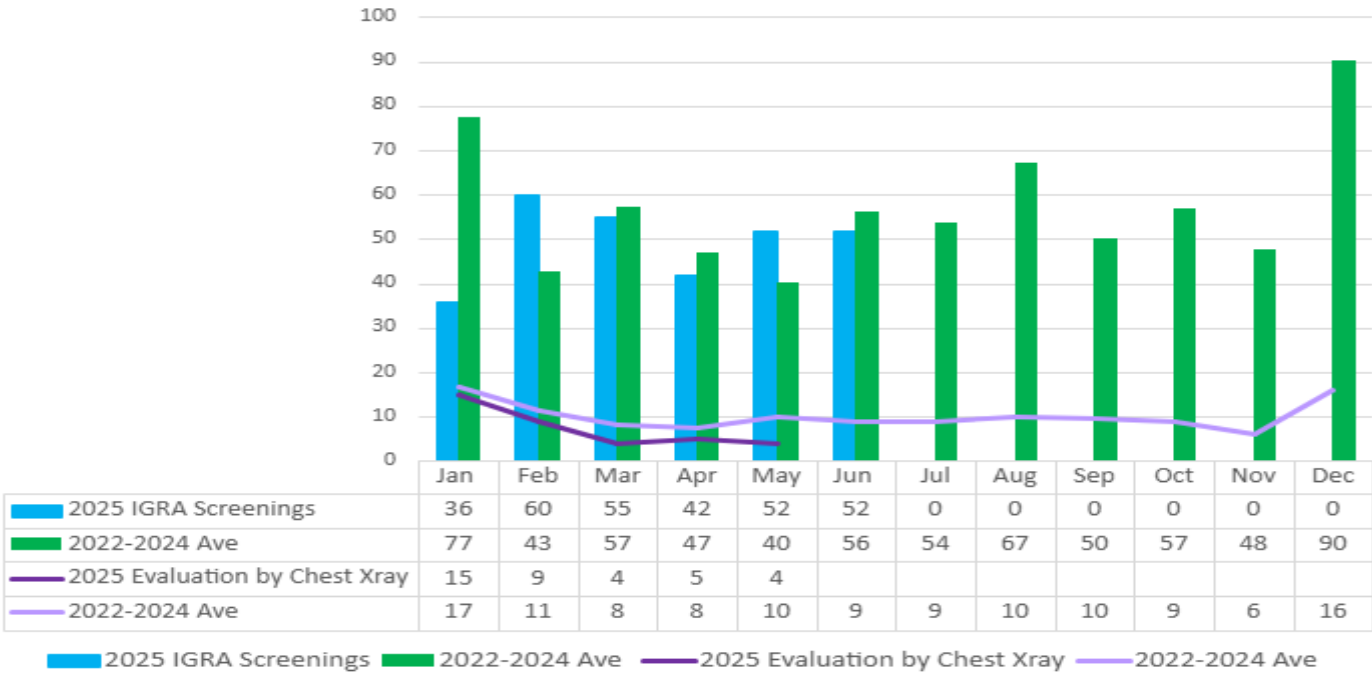

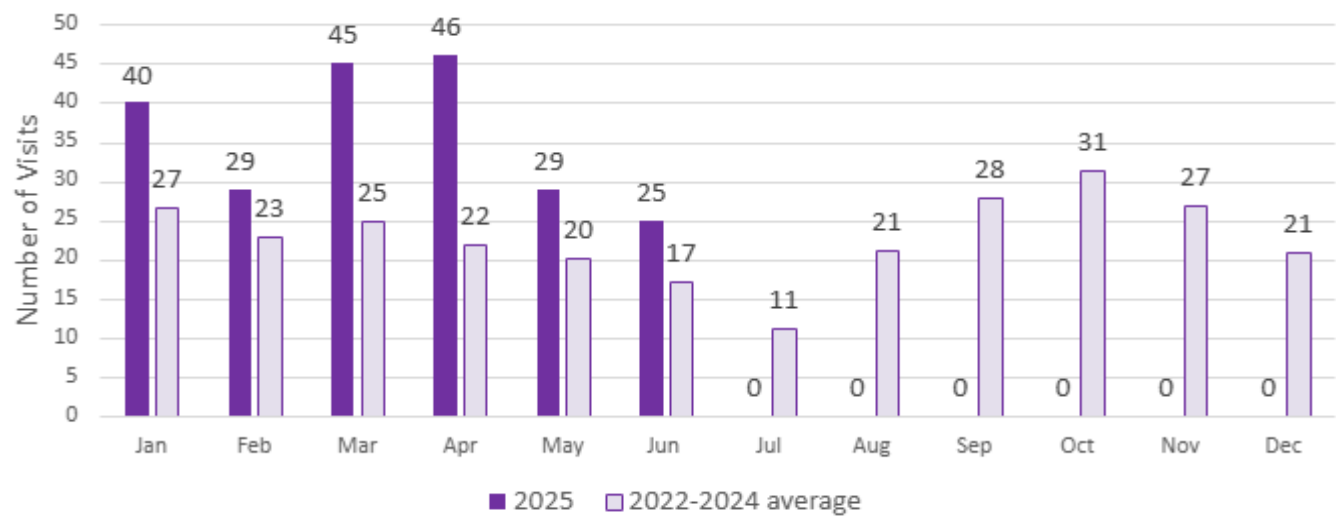

If classified as congenital syphilis, the event date is determined based on the reporting dates to either the local health department or the Ohio Department of Health, whichever is earliest. If classified as COVID-19, the event date is calculated based on specimen collection date, specimen received date, and specimen test result date, whichever is earliest.

Overview of the Flu Season

MMWR weeks 40 through week 20 is considered “flu season”. MMWR Week 40 started on September 29th, 2024, and MMWR Week 20 ended on May 17th, 2025. MMWR weeks are a system of numbering each week of the year so that weeks can be compared year to year for disease surveillance.

This year was a historically high flu season. The winter peak was well above the five-year average. The influenza-associated hospitalizations peaked in mid-February at 62 cases in one week.

Influenza-associated hospitalization data are retrieved from the Ohio Disease Reporting System (ODRS) and Emergency Department data are retrieved from EpiCenter Syndromic Surveillance System.

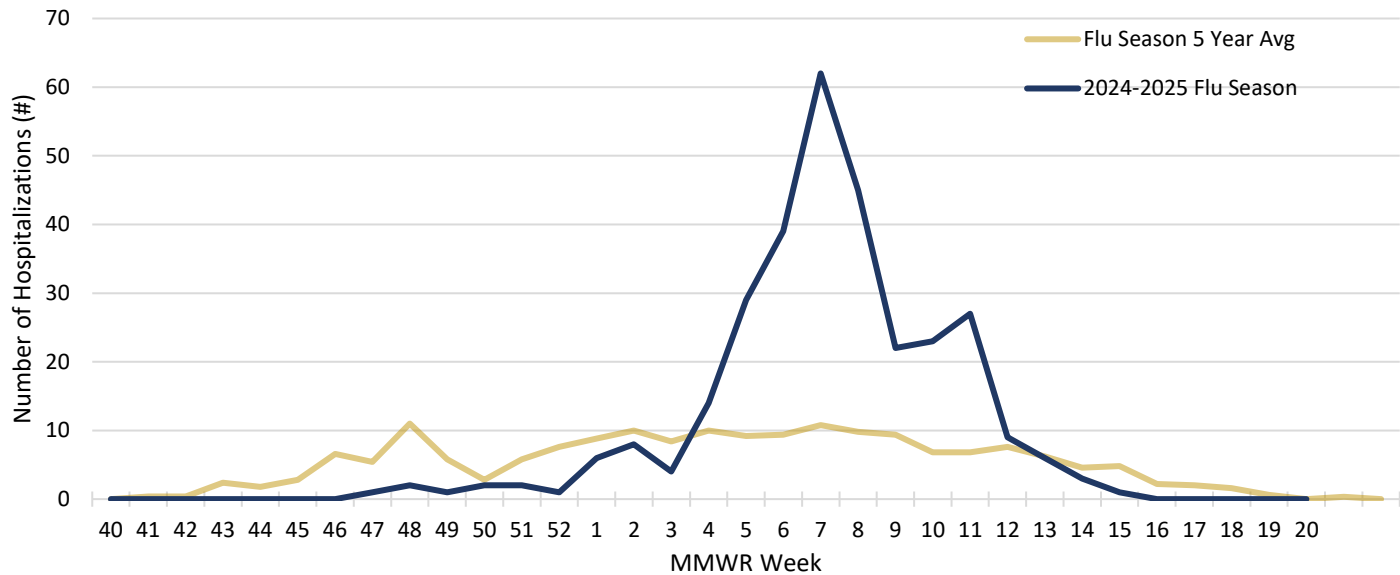


Figure 1: Influenza-associated Hospitalizations in Clark County, OH; 2024-2025 flu season compared to 5-year average**. Data queried from Ohio Disease Reporting System (ODRS) Data Extract on 7/3/2025. These are preliminary numbers and may change based on updated ODRS data.

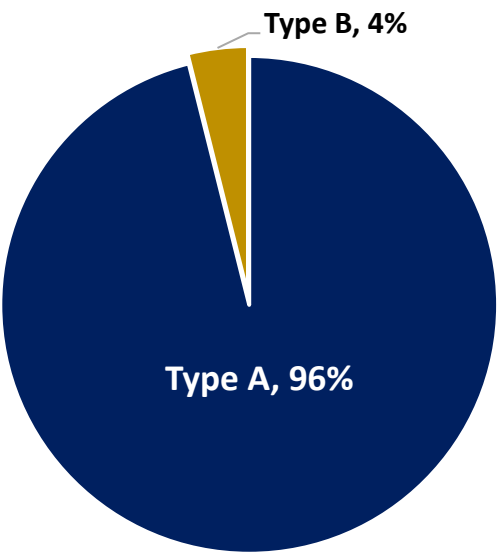


Figure 2: Confirmed Influenza-Associated Hospitalizations in Clark County, by flu type. MMWR Weeks 40 – 20 (9/29/2024 – 5/17/2025). Data queried from ODRS Data extract on 7/3/2025.

Percentage of hospitalized influenza A cases, Clark County

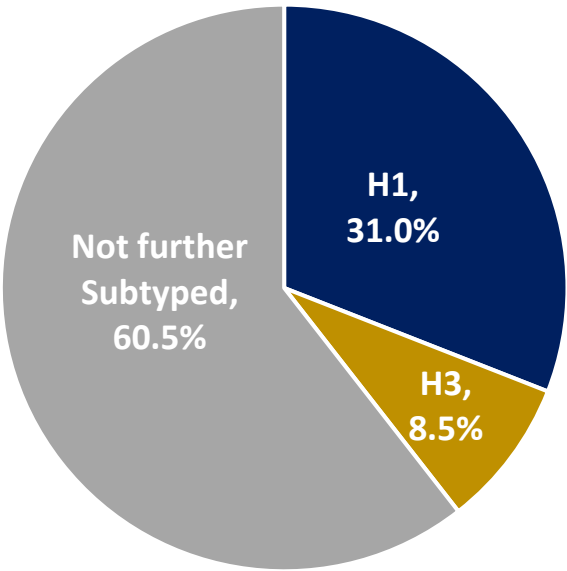


Figure 3: Confirmed Influenza-Associated Hospitalizations in Clark County, by Flu Type A Subtypes. MMWR Week 40 – 20 (9/29/2024 – 5/17/2025). Data queried from ODRS Data extract on 7/3/2025.

Percentage of hospitalizations in each age group in Clark County, 2024-2025 Flu Season

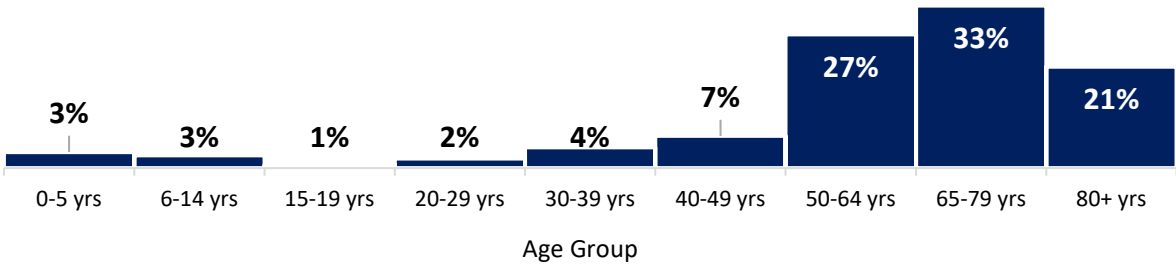


Figure 4: Confirmed Influenza-Associated Hospitalizations in Clark County, by age group. MMWR Weeks 40 – 20 (9/29/2024 – 5/17/2025). Data queried from ODRS Data extract on 7/3/2025.

Percentage of weekly ED visits in Clark County, 2024-2025 Flu Season

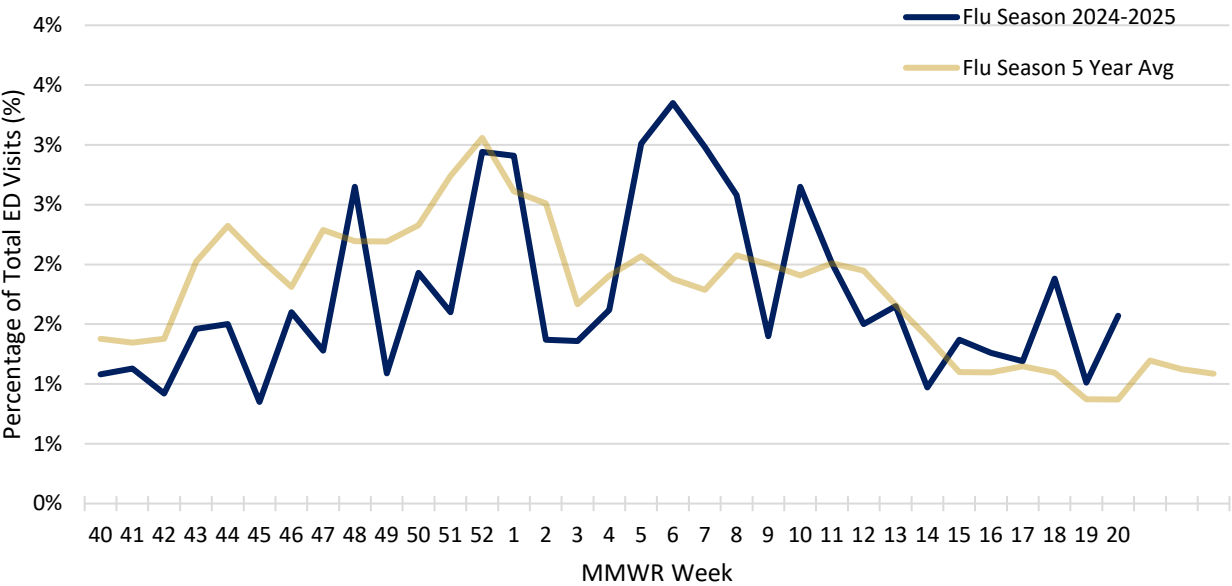


Figure 5: Percentage Fever and Influenza-Like-Illness (ILI) Specified ED Visits in Clark County, OH, compared to 5-year average**. Data queried from EpiCenter Syndromic Surveillance System on 7/3/2025.

Percentage of weekly ED visits in Clark County, 2024-2025 Flu Season

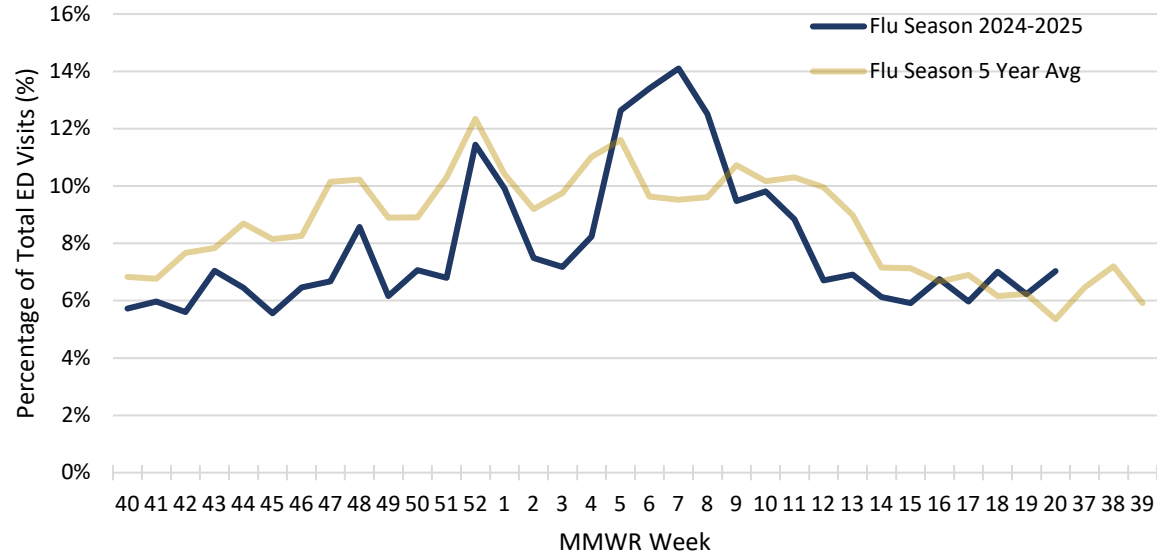


Figure 6: Percentage Constitutional ED Visits in Clark County, OH, compared to 5-year average**. Data queried from EpiCenter Syndromic Surveillance System on 7/3/2025.

Drug Overdose Prevention

- **One2One**
 - Second Harvest Food Bank (SHFB) Partnership: over the month of June, we provided food to 260 clients.
 - Sheltered Inc. Partnership: over the month of June, we completed 0 housing referrals.
 - Department of Job and Family Services Clark County Partnership: over the month of June, we assisted 2 clients in completing applications for Medicaid and SNAP benefits.
 - Harm Reduction Program stats from May 2025 (this data is always 1 month behind):
 - Client Visits: 310
 - Syringes Exchanged: 11,959
 - Narcan Kits Distributed: 85
 - Treatment Referrals: 3
- **Substance Abuse/DOP**
 - Program staff continue to support the health navigators that have been placed in Montgomery, Butler, and Greene Counties.
 - The navigators have had 401 unique encounters since the beginning of March where they were able to provide naloxone, test strips, among other services to individuals.
 - Program staff are currently partnering with the department of public safety to bring an Operation BRIDGE Day to Clark County.
 - Operation BRIDGE is an initiative that brings public health and public safety together to provide connection to services while public safety works to get substances off the street.
 - The Operation BRIDGE event will be taking place at the end of August on the 28th and 29th. At this event individuals will get to meet with treatment providers among many other community partners. 18 vendors are currently signed up and are looking to add more.



Adolescent Health

- The program has continued to develop relationships with youth serving organizations and other community stakeholders to serve on the grant's advisory committee.
- Program staff has continued to schedule trauma informed care training with local youth serving organizations.
- LifeSports Camp is officially underway. 43 youth are participating in the month-long program at Lincoln Elementary School.

Safe Communities

- Over the past month program staff have participated in several community events to increase community awareness of the dangers of distracted driving and seat belt usage for both teens and adults.
- The Clark County Fair officially kicks off on July 18th. Safe Communities/CCCHD will be represented throughout the week in the Mercantile building.

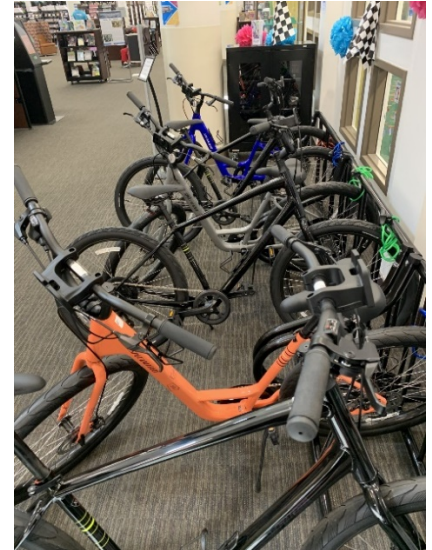

Tobacco

- Throughout the past month, program staff have continued to foster new partnerships throughout the community.
- In partnership with the Clark County Sheriff's office, compliance checks were completed on Clark County tobacco retailers that are not located within Springfield City Limits. The compliance checks were completed on June 17th. 32 stores were checked and 3 stores sold tobacco products to the underage purchasers. Follow-up retailer education will be provided to the stores that failed.
- Program staff have continued to advocate and plan for Tobacco retailer license policy enhancements.
- Notice of Award was received for the FY26 Tobacco grant. The total funding amount is \$122,350 and the grant year runs from July 2025 to June 2026.

Creating Healthy Communities

- CHC continues to be an active member of several local coalitions and taskforces, such as the Clark County Local Foods Council and the Chronic Disease Taskforce.
 - The cardiovascular workgroup has planned 4 HeartStrong events for 2025. The locations will be: CCPL, USS, Groceryland and the YMCA.
- The Bike Share program in partnership with the Clark County Public Library officially launched on June 23rd.



Lead

- Official Lead program activities ended on June 30th. Existing program staff will be transitioned into other health planning programs.
